OLD BUSINESS:

Trustee Seehausen made a motion to postpone discussion of Village Attorney Franklin Burkey requests reconciliation in the amount of \$4,406.00 for calendar year 2009 and a new billing amount of \$3,700.00 per month until after Executive Session. Trustee Peterson made a motion to approve a contribution of \$250.00 to Senior Services of Will County. Trustee Kozy seconded the motion. Roll was called and the following Trustees voted aye: Banicki, Seehausen, Kozy, Lopez, Peterson and Honea. President Sherman voted aye. Motion carried.

Discussion of use of Village Vehicles by Village employees - Trustee Honea made a motion to place on the April 5th Board meeting agenda- Use of Village vehicles. Trustee Honea moved that prior to the April 5th meeting, each Trustee Liaison and his/her Department's Head must meet with the Village President and discuss which of its personnel will be allowed to use a village vehicle to commute to and from work. Trustee Lopez seconded Trustee Honea's motion. Voice vote; all ayes. Motion carried.

NEW BUSINESS:

Trustee Honea made a motion to postpone scrapping or recycling two generators at the Fire Department Headquarters until their condition can be evaluated. Trustee Honea will ask the Fire Department to move the generators indoors. Trustee Lopez seconded the motion. Voice vote; all ayes. Motion carried.

Trustee Seehausen made a motion to approve the request of Scott Haugh, CEO of Save Your Glass for four (4) parking spaces at the K Mart parking lot every other month beginning April or May 2010 at \$700.00 minimum per month. Trustee Kozy seconded the motion. Roll was called and the following Trustees voted aye: Banicki, Seehausen, Kozy, Lopez, Peterson and Honea. President Sherman voted aye. Motion carried.

Trustee Seehausen made a motion to accept the low bid of Iroquois Paving at the March 15th bid opening, as recommended by the Village Engineer for the Halsted Boulevard Phase II project. Trustee Kozy seconded the motion. Roll was called and

Trustee Honea made a motion approve a budget not to exceed \$6,000 for the Steger Day event on August 28th in conjunction with the Fire Department Street Dance. Trustee Kozy seconded the motion. Trustee Honea expressed her intent to collect donations to further reduce the costs of the event. Trustee Peterson expressed concern for spending \$6,000 on Steger Day when Village employees have not received pay raises and Village vehicle privileges are under consideration. Roll was called and the following Trustees voted aye: Banicki, Seehausen, Kozy, Lopez and Honea. Trustee Peterson voted no. President Sherman voted aye. Motion carried.

Trustee Honea made a motion to table the request from Summer Band Director Candice Haldeman for a budget of \$3,200.00 for the 2010 Summer Band. Trustee Honea stated that the budget had allowed for the band's participation in the Steger Days parade, which has been canceled for this year. Trustee Honea will personally contact Candice Haldeman to advise her of the change and request a reduced budget request. Trustee Seehausen seconded the motion. Voice vote; all ayes. Motion carried.

Trustee Seehausen made a motion to approve the Joint Purchasing Requisition with the State of Illinois for 2010-11 road salt at a possible price increase not to exceed 5% over the 2009-10 season price. Trustee Banicki seconded the motion. Roll was called and the following Trustees voted aye: Banicki, Seehausen, Kozy, Peterson, Lopez and Honea. President Sherman voted aye. Motion carried.

Trustee Seehausen made a motion to direct the Village Attorney to draft an ordinance to rescind Ordinance No. 849 An Ordinance Establishing the Position of Village Administrator. Trustee Banicki seconded the motion. After discussion, the Roll was called and the following Trustees voted aye: Banicki, Seehausen, Lopez and Honea. Trustees Kozy and Peterson voted no. President Sherman voted aye. Motion carried.

Trustee Seehausen made a motion to approve the Business License application of PMJ Enterprises, Inc. at 3222 Keeney Avenue, pending inspections. Trustee Kozy seconded the motion. Voice vote; all ayes. Motion carried.
