Roll was called and the following Trustees voted aye: Seehausen, Kozy, Peterson and Honea. President Sherman voted aye. Motion carried.

NEW BUSINESS:

Trustee Peterson made a motion to adopt ORDINANCE NO. 1001 <u>AMENDING</u> ORDINANCE NO. 978 REGARDING SANITARY AND SEWER CHARGES AND THE <u>ASSESSMENT FOR SEWER LINE REHABILITATION AND MAINTENANCE</u>.

Trustee Honea seconded the motion. Roll was called and the following Trustees voted aye: Seehausen, Kozy, Peterson and Honea. President Sherman voted aye. Motion carried.

After discussion, Trustee Honea made a motion to require Maytag Laundry/Amado Wash, LLC to make a payment of \$2,500.00 (toward its water bill) on June 22, 2010 by 5pm. If the payment is not received by 5pm on June 22nd, water service will be discontinued. The entire balance of Maytag's water bill must be paid within the next 4 weeks (not later than July 20, 2010). Trustee Peterson seconded the motion. Roll was called and the following Trustees voted aye: Seehausen, Kozy, Peterson and Honea. President Sherman voted aye. Motion carried.

Trustee Seehausen made a motion to approve the request from Kiwanis Club of Steger to hold its annual Peanut Day on Friday September 24, 2010 at major intersections of the Village. Kiwanis also requests Orange Safety Cones from Public Works for the event. Trustee Honea seconded the motion. Voice vote; all ayes. Motion carried

Trustee Honea made a motion to table the Agreement between the Village of Steger and Attorney Franklin D. Burkey in the amount of \$44,000 per year until the July 19th Board Meeting. Trustee Seehausen seconded the motion. Voice vote; all ayes. Motion carried

Trustee Seehasuen made a motion to change the work policy to provide for the purchase of safety glasses for Public Works employees who wear prescription lenses, as requested by Superintendent of Public Works Bill Cox. The cost is approximately \$75.00 per pair. Trustee Peterson seconded the motion. Roll was called and the following Trustees voted aye: Seehausen, Kozy, Peterson and Honea. President Sherman voted aye. Motion carried.

Trustee Honea made a motion to approve the request of Fire Chief Al Martinez to approve of Billy Perry as a probationary Firefighter pending background checks and a physical examination. Trustee Peterson seconded the motion. Voice vote; all ayes. Motion carried

Trustee Peterson made a motion to approve the low bid of Iroquois Paving for the Emergency Road Program, as recommended by Village Engineer Joe Schudt. Trustee Kozy seconded the motion. Voice vote; all ayes. Motion carried.

Trustee Honea made a motion to permit K Mart to encroach onto the Village's property to expand its sidewalk to make it ADA compliant. Trustee Peterson seconded the motion. Voice vote; all ayes. Motion carried.
