MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF STEGER, WILL & COOK COUNTIES, ILLINOIS

The Board of Trustees convened in regular session at 7:00 P.M. on this 2nd day of August, 2010 in the Municipal Building of the Village of Steger with President Sherman in the Chair and presiding and Village Clerk Carmen S. Recupito, Jr. attending.

The Village Clerk called the roll and the following Trustees were present: Seehausen, Kozy, Lopez, Peterson and Honea. Trustee Banicki was absent. Also present were Village Engineer Joseph Schudt, Fire Chief Al Martinez, Police Chief Richard Stultz, ESDA Director Roger Mumford and Village Attorney Franklin Burkey.

MINUTES

Trustee Seehausen moved that the reading of the July 19th Board Meeting minutes be dispensed with and they be accepted as written as all members have copies. Trustee Honea seconded the motion. Voice vote; all ayes. Motion carried.

Trustee Seehausen moved that the reading of the July 19th Appropriation Hearing minutes be dispensed with and they be accepted as written as all members have copies. Trustee Kozy seconded the motion. Voice vote; all ayes. Motion carried.

TRUSTEE HONEA'S REPORT

Trustee Honea reported that in July 2010 the Fire Department responded to fifty eight three (58) ambulance calls and twenty three (23) fire calls. There were one hundred and eight (108) hours of Firefighter training, One hundred ninety four (194) hours of Firefighter II training and twenty four (24) hours of Special training.

Trustee Honea also reminded the Board and those present that Steger Day will be held at Veterans Park on August 28th.

TRUSTEE PETERSON'S REPORT

Trustee Peterson reported that in June the Police Department responded to One thousand four hundred thirty six calls. Fifty of those calls resulted in ticket and twenty two of them were arrests. The Illinois Criminal Justice Authority Grant has been completed. With the funds, the Police Department has purchased a 2010 Ford Crown Victoria squad car, all necessary equipment, eight mobile car radios and nine hand held portable radios. \$34,474.00 has been received in this grant with no matching funds required by the Village.

The Firemen's Park concession stand was broken into in July. The air conditioner was pushed in from the outside and items stolen from the concession stand. Sgt Gerald Ruff and Detective Pete Fajman found a group of juveniles with the missing items. The juveniles were turned over to their parents and petitioned to juvenile
