MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF STEGER, WILL & COOK COUNTIES, ILLINOIS

The Board of Trustees convened in regular session at 7:00 P.M. on this 17th day of June, 2013 in the Municipal Building of the Village of Steger with President Peterson in the Chair and presiding and Village Clerk Carmen S. Recupito, Jr. attending.

The Village Clerk called the roll and the following Trustees were present: Banicki, Skrezyna, Kozy Lopez and Perchinski. Also present were Village Engineer Joseph Schudt, Community Center Director Diane Rossi, Code Enforcer Ed Myers, and Superintendent of Public Works Bill Cox, Acting ESDA Coordinator Norman Flaig, Fire Chief Jeff Roesner and Police Chief Richard Stultz.

COMMENTS FROM THE FLOOR

Susan Mumford of Halsted Boulevard approached and asked that the Board consider installing street lights on Halsted Boulevard. Mayor Peterson will look into it.

Meredith Horn of 22805 State Street presented six possible solutions to excessive discharge into ditches on State Street from Wentworth, 34th Street Sandy Ridge and Sofia Court. The discharge makes many yards unusable to the owners. Mayor Peterson will look into the situation and start working on it.

Sherry Flaig of 3523 Sangamon Street explained that when she purchased her home seen years ago she was not notified that a storm sewer is behind her fence in the back yard. Ms. Flaig has been flooded out four times in the seven years. Ms. Flaig has received assistance from FEMA. Ms. Flaig suggested the Village purchase her home, demolish the home and use the property as retention pond. Village Engineer Joe Schudt explained that drainage/storm sewer problems in the Village are currently under review. Mr. Schudt explained that the storm sewers on the south side of town are marginal. Mayor Peterson will keep Ms. Flaig up to date on further findings.

COMMUNITY CENTER

-Diane Rossi, Community Center Director reported A.J. Florez, part time worker at the Community Center has given his two weeks' notice. Mrs. Rossi explained that with summer activities starting she needs to have a replacement as soon as possible. Mayor Peterson explained that Mrs. Rossi needs to continue accepting employment applications and make her recommendation to the Board at the next Board meeting.

PUBLIC INFRASTRUCTURE

- -Trustee Banicki referred to Ed Myers, Code Enforcement.
- -Ed Myers of Code Enforcement reported that the summer grass crew has cut 75 properties so far this summer. Another 4-5 in Miller Woods are difficult to cut because of the length of the grass. Supt. Of Public Works will loan equipment to Code Enforcement to assist with the Miller Woods properties.
- -Mr. Myers is working on zoning of a lot for a manufactured home on 34th Street and Kim Construction's FBI storage building.
- There have been 13 reoccupancy inspection completed in the prior two week period.
 - -Trustee Banicki referred to Superintendent of Public Works Bill Cox.
- -Superintendent of Public Works Bill Cox reported that the Dept. is mowing public areas and delivering picnic tables. The Department has been chipping branches that were downed in the recent storms. The Water Department continues to install radio read meters and all water samples came back from the Illinois EPA as satisfactory. Mr. Cox reported that the stop signs at 225th Street are now installed. One water main break was repaired since the previous Board meeting.

The homeowner was unwilling to cooperate. The homeowner's property will not be damaged by the work. Mr. Schudt recommended condemnation of the property. Trustee Lopez seconded the motion.
