The Board of Trustees convened in regular session at 7:00 P.M. on this <sup>7TH</sup> day of January, 2019 in the Municipal Building of the Village of Steger with the Village Clerk Joseph M Zagone, Jr. attending. Clerk Zagone led all in attendance in the Pledge of Allegiance to the flag.

### **MINUTES**

### **AUDIENCE PARTICIPATION**

Chairman Pro Tem Lopez announced that starting tonight anyone wishing to speak needed to sign in prior to the meeting and will be given three minutes.

Mary Laws of 3437 Jennifer Ct asked if they could be more specific on what property Resolution 1130 on the Agenda was referring to. Trustee Perchinski stated it was for a new business going in on 35<sup>th</sup> St & Chicago Rd, and the Village is trying to help with TIF funds to renovate the building.

Ms. Laws also inquired about Resolution 1131, wanting to know if we lost officers or safety personal. Trustee Perchinski stated we have been working with a skeleton crew and need to hire more officers. He also referred to Fire Chief Fillion who stated

that we are looking to add another ambulance crew at Station 2 to cut down on mutual aid and provide residents a more timely response.

Ms. Laws also asked Chief Rossi if he could elaborate regarding reports on a shooting around Eastview. Chief Rossi stated they received calls from all areas of the community regarding shots fired. Officers checked the areas, but no one saw anything, no evidence was found and no reports of damage were reported.

Ms. Laws thanked everyone for the clarity on the issues.

# **REPORTS**

**Village Administrator Mary Jo Seehausen** reported that the annual Christmas tree burn will take place at Veteran's Park on Friday, January 11, 2019 at 6:00 pm if anyone wants to drop their trees off.

Administrator Seehausen also reported there will be a zoning meeting on Thursday, January 10, 2019 at 6:00 pm for the architectural design overlay.

Administrator Seehausen added that the Village has received approval from the CSX to do our set of crossings and will be moving forward with them. Administrator Seehausen and Public Infrastructure Director Toepper are discussing prices on concrete, and considering putting it in with the sidewalks at 34<sup>th</sup> & Union.

Director of Public Infrastructure Dave Toepper no report.

**Fire Chief Nowell Fillion** reported that in January the department will be offering CPR classes. Heart saver on the 17<sup>th</sup> with a certification and Friends and Family on the 24<sup>th</sup> which is just informational. Both classes begin at 6:00 pm. He stated they will keep everyone up to date on when more classes will be held.

Chief Fillion also informed everyone that the department has partnered with the Illinois Fire Safety Alliance and will be offering the fire smoke detector installation program again. Smoke detectors are provided and the fire department will install with no charge to the residents. Contact the Fire Station or info@stegerfire.org for more information.

Chief Fillion reported that total calls for 2018 were 1638. He noted that Steger is the second busiest department in the East Mabas District and the department has had 31 calls in the last 5 days.

Police Chief Patrick Rossi referred to his weekly report, and then elaborated on the question from the audience regarding Resolution1131. He stated there has been a lot of down time due to officers injured on duty and an increase in calls. He stated Steger is one of the lowest staffed departments in the area, but has some of the higher calls for service in the area. New mandates on certain calls now take officers much

longer. He stated it is important to have more man power to provide good safety for the residents.
