<u>PRESIDENT PETERSON</u> Commended EMA for their recent efforts in keeping the public aware of coming storms that recently came through our Village. I appreciate everyone's efforts on that.

The floor was turned over to Patrick D'Heff with the Illinois Coalition of Local Governments who had arrived and was ready to make his presentation. Mr. D'Heff's program would work on behalf of the Village of Steger as the third-party administrator for the compliance review, collection and distribution of the 2% Foreign Fire Insurance Company Tax Due to the Village. The program described would increase the Village revenue due to our Fire Department by pursuing past revenues not collected and by reducing percentage paid by the Village for this service. The Coalition of Local Governments created this program to be better than what is currently in place. We make it cheaper and faster for the Village to recoup these funds. The program is better by streamlining the process through technology and then reducing costs by about 50% and making the process faster. Mayor Peterson added that the program is currently being provided at rate of 7% by the Illinois Municipal League. This new program would provide the same service for 3.5% plus insure that any previous revenue missed would also be collected. Administrator Seehausen added that Compliance Review is the most important part of the program as it will probably bring more revenue. These funds then go directly to the Fire Department.
