Trustee Joyce seconded the motion. Roll was called. The following Trustees voted aye; Joyce, Kozy, Lopez, Skrezyna and Buxton. Mayor Peterson voted aye. Motion carried

Trustee Joyce made a motion to adopt Ordnance No 1211, An ordinance amending Chapter 10 of the Municipal Code of Steger, Illinois by adding regulations regarding raffles for the Village of Steger, Illinois. Trustee Lopez seconded the motion. Roll was called. The following Trustees voted aye; Joyce, Kozy, Lopez, Skrezyna and Buxton. Mayor Peterson voted aye. Motion carried.

Mayor Peterson opened discussion of the Public Hearing on the 2019 Appropriation Budget. The budget that was handed out showed that we were not balanced by \$187,000, but found additional expenditures that were not correct and we are now out of balance by \$229,000 give or take. We are working really hard to try to get this in balance because obviously we want a balanced budget, so we have given ourselves a week to do that. We have to get this done by the 31st so there will be a public hearing on March 28th at 6:45 and then there will be a special meeting at 7 o'clock

immediately thereafter and we really need everyone to look at the budget and give us your thoughts. We are about as lean as we can get. I thought there was a lot we could cut, but there's really not a lot to cut. We really need to look at the revenue side of our budget to get that up as much possible so that we have services to deal with drainage, water, roads. It becomes harder and harder every year to continue because our revenues are pretty flat but costs go up. We need to start getting business, more residents to create more income tax because we want to avoid increased real estate taxes. Sales tax is key, but gaming is the only revenue source that has been increasing. Department Heads are asked to revue anything they can do with costs and we will be back next week to try and get this balanced.

There being no further business,

Trustee Joyce made a motion to adjourn the meeting. Trustee Skrezyna seconded the motion. Voice vote; all ayes. Motion carried.

# AN ORDINANCE AUTHORIZING AND APPROVING AN INTERGOVERNMENTAL AGREEMENT WITH THE CHICAGO HEIGHTS PARK DISTRICT FOR THE VILLAGE OF STEGER, ILLINOIS.

WHEREAS, the Village of Steger, Counties of Cook and Will, State of Illinois (the "Village") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefit of the residents of the Village; and

WHEREAS, the Intergovernmental Cooperation Act (5 ILCS 220/1, et seq.) (the "Act") authorizes public agencies, which include units of local government and agencies of the government of the State of Illinois, to jointly enjoy and/or exercise powers, privileges, functions or authority with other public agencies, except where specifically and expressly prohibited by law; and

WHEREAS, the Chicago Heights Park District (the "Park District") is a park district organized under and governed by the Park District Code (70 ILCS 1205/1-1, et seq.); and

WHEREAS, the Village, through its Recreation Department, oversees and supports a youth football and cheer program (the "Football Program"); and

WHEREAS, the Park District desires to enable children to register for the Football Program through the Park District; and

WHEREAS, the Village desires to use the football field located at Bloom High School (the "Bloom High Field"), to the extent the Park District is entitled to use the Bloom High Field, for activities in connection with the Football Program; and

WHEREAS, the Park District desires to use the Village's football field (the "Village Field") for activities in connection with the Football Program; and

WHEREAS, the Village and the Park District desire to enter into a certain Intergovernmental Agreement (the "Agreement"), a copy of which is attached hereto and incorporated herein as Exhibit A, whereby the Village will accept registrations for the Football Program through the Park District, the Park District will allow the Village to use the Bloom High Field for activities in connection with the Football Program, to the extent the Park District is entitled to use the Bloom High Field, and the Village will allow the Park District to use the Village Field for activities in connection with the Football Program; and

WHEREAS, based on the foregoing and in order to ensure the health, safety and welfare of the Village and its residents, the Village President (the "President") and the Board of Trustees of the Village (the "Village Board" and with the President, the "Corporate Authorities") have determined that it is advisable and in the best interests of the Village and its residents to enter into and approve an agreement with terms substantially the same as the terms of the Agreement; and

WHEREAS, the President is authorized to enter into and the Village Attorney (the "Attorney") is authorized to revise agreements for the Village making such insertions, omissions and changes as shall be approved by the President and the Attorney;

**NOW, THEREFORE, BE IT ORDAINED** by the President and the Board of Trustees of the Village of Steger, Counties of Cook and Will, and the State of Illinois, as follows:

#### ARTICLE I.

#### IN GENERAL

#### **SECTION 1: Incorporation Clause.**

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Ordinance are full, true and correct and do hereby, by reference, incorporate and make them part of this Ordinance as legislative findings.

#### SECTION 2: Purpose.

The purpose of this Ordinance is to authorize the President or his designee to enter into the Agreement with the Park District and to further authorize the President or his designee to take all steps necessary to carry out the terms and intent of this Ordinance and to ratify any steps taken to effectuate those goals.

## ARTICLE II. AUTHORIZATION

#### SECTION 3: Authorization.

That the Village Board approves the Agreement. The Village Board further authorizes and directs the President or his designee to enter into and approve the Agreement, or any modifications thereof, and to ratify any and all previous action taken to effectuate the intent of this Ordinance. The Village Board further authorizes and directs the President or his designee to execute the Agreement with such insertions, omissions and changes as shall be approved by the President and the Attorney. The Village Clerk is hereby authorized and directed to attest to and countersign the Agreement and any other documentation as may be necessary to carry out and effectuate the purpose of this Ordinance. The Village Clerk is also authorized and directed to affix the Seal of the Village to such documentation as is deemed necessary. The officers, agents and/or employees of the Village shall take all action necessary or

reasonably required by the Village to carry out, give effect to and effectuate the purpose of this Ordinance and shall take all action necessary in conformity therewith.

# ARTICLE III. HEADINGS, SAVINGS CLAUSES, PUBLICATION, EFFECTIVE DATE

#### SECTION 4: Headings.

The headings of the articles, sections, paragraphs and subparagraphs of this Ordinance are inserted solely for convenience of reference and form no substantive part of this Ordinance nor should they be used in any interpretation or construction of any substantive provision of this Ordinance.

#### SECTION 5: Severability.

The provisions of this Ordinance are hereby declared to be severable and should any provision of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein, and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

#### SECTION 6: Superseder.

All code provisions, ordinances, resolutions, rules and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

#### SECTION 7: Publication.

A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

#### SECTION 8: Effective Date.

This Ordinance shall be effective and in full force immediately upon passage and approval.

#### **EXHIBIT A**

#### INTERGOVERNMENTAL AGREEMENT

THIS INTERGOVERNMENTAL AGREEMENT (the "Agreement") dated as of April \_\_\_\_, 2019, by and between the Village of Steger, Illinois, a municipal corporation (the "Village") and the Chicago Heights Park District, an Illinois park district (the "Park District") (collectively, the Park District and the Village may, for convenience be referred to as the "Parties", and each individually as a "Party")

#### **RECITALS**

WHEREAS, the Illinois Intergovernmental Cooperation Act (5 ILCS 220/1 et seq.), authorizes municipalities to exercise jointly with any public agency of the State, including other units of local government, any power, privilege, or authority which may be exercised by a unit of local government individually, and to enter into contracts for the performance of governmental services, activities and undertakings; and

WHEREAS, the Village is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto; and

**WHEREAS**, the Park District is a park district organized under and governed by the Park District Code, 70 ILCS 1205/1-1, *et seq.*; and

WHEREAS, the Village, through its Recreation Department, oversees and supports a youth football and cheer program (the "Football Program"); and

WHEREAS, the Park District desires to enable children to register for the Football Program through the Park District; and

WHEREAS, the Village desires to use the football field located at Bloom High

School (the "Bloom High Field"), to extent the Park District is entitled to use the Bloom High Field, for activities in connection with the Football Program; and

WHEREAS, the Park District desires to use the Village's football field (the "Steger Field") for activities in connection with the Football Program; and

WHEREAS, the Village and the Park District desire to enter into this Intergovernmental Cooperation Agreement (the "Agreement") whereby the Village will accept registrations for the Football Program through the Park District, the Park District will allow the Village to use the Bloom High Field for activities in connection with the Football Program, to the extent the Park District is entitled to use the Bloom High Field, and the Village will allow the Park District to use the Village Field for activities in connection with the Football Program;

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual promises and benefits hereinafter set forth, the Parties agree as follows:

Section 1. Registration. The Village shall accept registrations for the Football Program from the Park District. The fee for registrations received from the Park District shall be One Hundred Twenty-Five and No/100 U.S. Dollars (\$125.00) per child.

Section 2. Bloom High Field. To the extent the Park District is entitled to use the Bloom High Field, the Park District shall allow the Village to use the Bloom High Field for activities in connection with the Football Program at such times as agreed upon by the Parties.

Section 3. Village Field. The Village shall allow the Park District to use the Village Field for activities in connection with the Football Program at such times as agreed upon by the Parties.

#### Section 4. Commencement and Term of Agreement.

This Agreement shall commence on April \_\_\_, 2019 and continue for a period of one (1) calendar year from the Commencement Date and shall automatically renew for successive calendar years thereafter, provided however, that either Party may terminate the Agreement after ninety (90) days written notice to the other Party. Either Party may terminate this Agreement at any time by providing the other Party with thirty (30) days prior written notice of such termination. In addition, the Parties may terminate this Agreement by mutual consent and agreement.

Section 5. Insurance. The Village shall provide to the Park District prior to the commencement of the Football Program, a Certificate of Liability Insurance with a coverage amount of no less than Two Million and No/100 U.S. Dollars (\$2,000,000.00), naming the Park District and all of its officers, agents, employees and public officials as additional insured's for any incidents or injuries or claims arising from the Football Program. The Park District covenants and agrees that the Village may elect to provide the coverage required by this Section 5 through a combination of the Village's liability and excess liability policies. The Parties agree that the Village's liability policy shall provide primary coverage for such claims, actions and liabilities, and the Park District owned liability policies shall provide secondary coverage for such claims.

#### Section 6. Indemnification.

Each Party will indemnify, defend and hold the other Party and its elected officials, agents, officers, employees and volunteers harmless from and against any claims, suits, proceedings, costs, liabilities, expenses (including court costs and reasonable legal fees), or damages (claims) to real or tangible personal property and/or bodily injury to persons,

including death, resulting from its or its elected officials, agents, officers, employees and volunteers gross negligence or willful misconduct arising from or related to this Agreement.

#### Section 7. Authority.

The execution, delivery and performance of this Agreement have been duly and validly authorized by all necessary action on the part of both Parties. This Agreement is a legal, valid and binding Agreement of the Village and the Park District, enforceable against either Party in accordance with its terms.

#### Section 8. Notice.

Any notice, demand, or request required or permitted to be given under the provisions of this Agreement shall be in writing and delivered personally or by registered or certified mail, postage prepaid, to the following persons and addresses, or to such other addresses or persons as either Party may designate by subsequent notice to the other Party:

Section 9. Governing Law.

This Agreement shall be construed in accordance with and governed by the laws

of the State of Illinois.

Section 10. Amendments.

No amendments, changes, modifications, alterations or waivers of any term,

provision or condition of this Agreement shall be binding or effective for any purpose

unless expressed in writing and adopted by each of the Parties hereto as required by law.

Section 11. Severability.

The terms, conditions and provisions of this Agreement shall be severable, and if

any term, condition or provision is found to be invalid or unenforceable for any reason

whatsoever, the remaining sections, subsections, terms, conditions and provisions shall

remain in full force and effect, and shall not be effective by such determination, unless

the Agreement can no longer be performed by any Party.

Section 12. Amendments.

No amendments, changes, modifications, alterations or waivers of any term,

provision or condition of this Agreement shall be binding or effective for any purpose

unless expressed in writing and adopted by each of the Parties hereto as required by law.

Section 13. Prevailing Party.

In the event of a default and/or litigation arising out of the enforcement, breach or

construction of this Agreement, the Parties hereto acknowledge and agree that the prevailing

Party shall be entitled to recover all costs, charges, expenses and reasonable attorneys' fees

arising as a result thereof. Prevailing Party shall mean any defendant found not liable on any

and all counts and/or any plaintiff recovering on any count.

#### Section 14. Counterparts.

This Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Facsimile signatures shall be sufficient unless an original signature is required by either Party. Reproduction of this Agreement and its signatures hereon shall be the equivalent of an original copy of this Agreement.

Additionally, the State of Illinois has adopted new reporting requirements for 2018 in connection with the *Grant Accountability and Transparency Act*. Requirements vary depending on the amount of state funding expended, but in the case of the Village, we expect that our additional fees related to this new requirement will not exceed \$1,500.

Either of us may terminate these services at any time. Both of us must agree, in writing, to any future modifications or extensions. If services are terminated, you agree to pay us for time expended to date. In addition, you will be billed travel costs and fees for services from other professionals, if any, as well as an administrative fee of 4% to cover items such as copies, postage and other delivery charges, supplies, technology-related costs such as computer processing, software licensing, research and library databases and similar expense items.

If any provision of this agreement is declared invalid or unenforceable, no other provision of this agreement is affected and all other provisions remain in full force and effect.

We may from time to time utilize third-party service providers, *e.g.*, domestic software processors or legal counsel, or disclose confidential information about you to third-party service providers in serving your account. We remain committed to maintaining the confidentiality and security of your information. Accordingly, we maintain internal policies, procedures and safeguards to protect the confidentiality of your information. In addition, we will secure confidentiality agreements with all service providers to maintain the confidentiality of your information. In the event we are unable to secure an appropriate confidentiality agreement, you will be asked to provide your consent prior to the sharing of your confidential information with the third-party service provider.

This engagement letter represents the entire agreement regarding the services described herein and supersedes all prior negotiations, proposals, representations or agreements, written or oral, regarding these services. It shall be binding on heirs, successors and assigns of you and BKD.

The entity agrees that the aforementioned auditor's report, or reference to our firm, will not be included in any such offering document without notifying us.
