MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF STEGER, WILL & COOK COUNTIES, ILLINOIS

The Board of Trustees convened in regular session at 7:00 P.M. on this 7th day of June 2021 in the Municipal Building of the Village of Steger and via Teleconference that was made available to all residents. Mayor Peterson led all in attendance in the Pledge of Allegiance to the flag.

Mayor Peterson called the roll. The following Trustees were present, Thurmond, Kozy, Trotier, Perchinski, Buxton and Mayor Peterson. Trustee Joyce and Village Clerk Zagone were present via Zoom.

Also present: Director of Public Infrastructure Dave Toepper. Fire Chief Nowell Fillion, Police Chief Kevin Shaughnessy, Community Center Director Diana Rossi and EMA Chief Tom Johnston were present via ZOOM. Village Administrator Mary Jo Seehausen was absent.

AWARDS, HONORS AND SPECIAL RECOGNITION

Knight Engineering representative Clay Shipley presented the results of the Storm Water Drainage Study conducted over the past two years. Mr. Shipley detailed the areas most affected in the Village and described a series of improvements that can be made to the system. The findings showed inadequate lines to carry the water from west to east where our water drains into Thorn Creek to be carried away from the Village. Improvements include additional pipes to carry water to the creek, improvements to the two retention ponds on either side of the railroad tracks and study of Thorn Creeks ability to handle our stormwater. The Village is working with the Metropolitan Water Reclamation District for both funding and expertise their system might offer. There are also Federal Funds being sought to help finance the needs our Village faces. Knight Engineering is currently working on developing costs for the projects recommended to ease our drainage issues. A subsequent presentation will be made when this has been completed.

The resident at 65 W. 34th St. came before the Board to discuss issues regarding her sanitary sewer issues at her home. The house was the scene of an auto accident where a car left the roadway and did substantial damage to the front of the
