A representative of Republic Services addressed the board and spelled out the services to be provided to the Village and its residents for the term of the new contract. She also explained the increases that would occur each year. The five-year contract would extend services to the Village including free roll off dumpsters as needed as well as electronics pick-up on request. Increases would be 3 ½ % the first year and 5% the following 4 years. It was explained that the cost of equipment, trash containers and labor have all been on the rise with inflation. Trustee Perchinski questioned the length of term. Trustee Thurmond asked if because of our long relationship they would consider 4% increases.

Following Discussion:

Trustee Perchinski made a motion to table approval of the new Republic Services contract. Trustee Thurmond seconded the motion.

Due to the time sensitivity of the current contract expiring, it would be necessary for a special meeting before the end of the year, or ask Republic to extend the current contract while we negotiate the new contract. The representative is going to present the request for 4% across the board and get back to us.
