MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF STEGER, WILL & COOK COUNTIES, ILLINOIS

The Board of Trustees convened in regular session at 7:00 P.M. on this 21st day of February, 2023 in the Municipal Building of the Village of Steger and via Teleconference that was made available to all residents. Mayor Peterson led all in attendance in the Pledge of Allegiance to the flag.

The roll was called. The following Trustees were present; Lopez, Stewart, Trotier and Perchinski. Mayor Peterson was present. Trustees Thurmond and Joyce were absent.

Also present: Director of Public Infrastructure Dave Toepper, Fire Chief Michael Long, Police Chief Greg Smith, EMA Chief Tom Johnston and Community Center Director Diana Rossi. Village Administrator Mary Jo Seehausen was absent.

MINUTES

Trustee Perchinski made a motion to approve the minutes of the February 6th meeting as all members have copies. Trustee Lopez seconded the motion. Voice vote; all ayes. Motion carried.

AUDIENCE

Gerald Brossmer of Steger approached the board regarding issues he has encountered. Mr. Brossmer is former Director of Public works for the Village and has held similar positions in surrounding communities. His issue is with Nicor Gas and the subcontractors doing the work in the village. Mr. Brossmer has had several conversations with Dave Toepper regarding these issues, the first of which is that Nicor sprayed markings on the sidewalk to show that work was planned, but never received a letter explaining what work was to be done. He believes the Village needs to address the subcontractors that are doing this work. I have directed the contractor and Nicor Gas that they are not to enter his property or make any attempt to run a new line through his property. Mr. Brossmer described issues he has had with encounters with Steger Police. There has also been an issue with Mr. Brossmer's water bill that was incorrectly read and double billed. Discussion has been had with Dave Toepper and Mayor Peterson explained that he would investigate this issue and get it resolved without penalty. He brought a \$511 water bill and he said I have never been late paying my bill. Mr. Brossmer further described a situation when there was a problem with the old water tower. He was asked to come in and was able to correct the issue. Mr. Brossmer has been instrumental with several surrounding communities working to help with water transmission lines. While

Mr. Brossmer appreciates the work Nicor needs to do, they cannot dig up our yards. I cannot allow Nicor Gas to turn my yard into a disaster zone when it doesn't have to be handled that way. I don't have a problem disconnecting from Nicor and putting in a propane tank. Nicor has told Mr. Brossmer that they will try to work with him on this project. I have always been a person who doesn't hold back and pretty much say what is on my mind. I just want to let the Village know to be aware that there is an entity out there that is not going run away or cower from these utilities. I had gone to the police department and told them that I am trying to be reasonable and honorable with this, the officer recommended that I bring my issues to the Village Board. Mayor Peterson and Dave Toepper are going to look into the work and damage that may be done to property. Mayor Peterson stated that he would look into both his issues. Mr. Brossmer concluded offering his services if they are ever needed.

Resident Ricardo Sanchez approached the board regarding an abandoned house at 28 West 30th Street. Mr. Sanchez has been trying to research the ownership in hopes of acquiring the property if it is available either through auction or back taxes. Dave Toepper believes the property may have recently sold, but is going to find out for sure and let Mr. Sanchez know the status of the property. Mayor Peterson described how the Village deals with houses that it acquires, but that house is not one of them.

Fire Chief Michael Long Reported on a couple of educational things this week: Troy Meyers, Eric Leach and Brendon Munoz completed their HazMat Operations, so they are fully certified. Police Chief Greg Smith We have inquired about getting some of those auto steering wheel locks to deal with Hyundai and Kia theft issues. Steger Police Department contacted both auto makers and both are sending a supply of these locks to the Village that will be distributed on a first come first serve basis. The public will be informed on Facebook when they are available for cars that require keys to start. Autos with pushbutton start are not affected.
