- 3/10 Unwanted Subject – 3332 Chicago Rd. (VFW). VFW staff told police an intoxicated subject entered the bar. Business refused to serve subject and requested he leave. The subject was provided a ride by a friend.
- 3/10 Domestic Dispute – 3600 Block of Chicago Rd. Verbal altercation, parties separated prior to police arrival.
