- Domestic Dispute 0-100 Block of 31st St. Verbal altercation, parties separated prior to police arrival. Information provided for obtaining an Order of Protection. The other person involved in the altercation was located in the area. Subject was intoxicated and transported by the SFD to St. James Hospital for an evaluation.
- 5/7 Attempted Burglary 3325 Chicago Rd. (Little Caesars). Offenders unknown broke the glass on the door to gain entry into the business. The offender's attempted to pry the safe open but were unsuccessful. Police checked the area, but met with negative results. Police are investigating.
- 5/7 Criminal Trespass to Motor Vehicle 3200 Block of Chicago Rd. Witnesses observed the offender, later identified as Mason W. Bailey, 21, of New Lenox inside their vehicle. Mason fled the scene, but got caught in a fence. Bailey was issued a local ordinance citation for Criminal Trespass. SFD was summoned to the scene and transported Baily to St. James hospital due to high level of intoxications and injuries he sustained.
- 5/7 Domestic Disturbance 3000 Block of Butler Ave. Physical altercation ensued during a child custody exchange. Police are investigating.
- 5/8 Aggravated Domestic Battery 100 Block of Lake Hill Dr. Physical altercation, parties separated, police are investigating.
- 5/8 Criminal Damage to Property 3200 Chicago Rd. (Guaranteed Muffler). Offender unknown threw a piece of asphalt through a window, breaking the glass. Police are investigating.

Peace restored, report on file. 5/8 Burglary – 11 W. 34th St. (Brown Onion Pub) Offenders unknown gained access to the building by breaking the rear entry door. The offenders removed the money box from one of the gaming machines. Police are investigating. Traffic Arrest – 34th & Union. Savannah R. Dagostino, 22, of Steger was stopped 5/9 for speeding. Police detected the smell of cannabis emitting from the vehicle. A small amount of cannabis located, local ordinance citation issued. Domestic Battery - 0-100 Block of W. 35th St. Physical altercation involving a 5/9 juvenile offender. Juvenile was transported to the police department, placed on station adjustment and released to parents. Domestic Disturbance – 300 Block of W. 34th St. Verbal altercation, information 5/9 provided to obtain an Order of Protection, report on file. 5/9 Domestic Dispute, Public Intoxication – 500 Block of W. Richton Rd. Intoxicated subject attempted to gain entry into girlfriend's residence. The resident declined entry due to his intoxicated state. Subject told police he was going to hurt himself. SFD transported subject transported to St. James Hospital. 5/10 Child Custody Dispute – 21000 Block of Jim Johnson Ln. Verbal altercation, peace restore, report on file. Neighborhood Dispute – 100 Block of W. 34th St. Dispute over parking space, 5/10 peace restored.
- 5/10 Domestic Battery 3500 Block of Peoria Sr. Physical altercation, both parties transported to the hospital. Police are investigating, charges pending.

- 5/10 Possession of Stolen Motor Vehicle 300 Block of 35th St. Preliminary investigation revealed the vehicle was taken without permission by co-owner. Vehicle impounded and will be released to primary owner. No charges filed.
- 5/11 Child Custody Dispute 3000 Block of Hopkins Ave. Parents engaged in verbal dispute over custody of their children. Both parties came to an agreement, peace restored.
- 5/11 Criminal Damage to Property, Trespass 3400 Block of Kings Rd. Allen Antonio D. Horne, 21, of Calumet City left a dog and two cats in his apartment after being evicted. Horne forced entry into the apartment and damaged the door locking mechanism. The management company did not want to pursue criminal charges, but wanted Horne trespassed from the property. Horne was served with a trespass notice and released without further incident.
