The disturbance spilled out into the parking lot, where a second female patron was slapped by the offender. The offender was gone upon police arrival. Both victims refused prosecution.
- 7/1 Traffic Arrest – 34<sup>th</sup> & Carpenter St. Timothy J. Staley, 35, of Olympia Fields was arrested for DUI. Staley was processed and bonded.
