Peterson was processed and bonded. Harassment through Electronic Communications – 3700 Block of Stella Blvd. 7/8 Victim reported receiving harassing text messages from her ex-boyfriend. Information was provided to receive an Order of Protection. Domestic Dispute – 0-100 Block of W. 35th St. Verbal altercation between siblings. 7/8 Peace restored. Traffic Arrest – 35th & Union Ave. Kendall T. Amos, 20, of Glenwood was arrested 7/8 for Driving While Driver's License Suspended, Operation of Uninsured Motor Vehicle, and Failure to Yield.
