- 12/30 Aggravated Assault to a Peace Officer, Resisting a Peace Officer – 400 Block of W. 34<sup>th</sup> St. Steger Police responded to a report of an Unwanted Subject. Archie D. Dent, 18 of Chicago Heights refused to leave and threatened one of the police officers. Dent was arrested for Aggravated Assault of a Peace Officer & Resisting a Peace Officer. Dent was transported to the Police Department, where he was cited and released.
- 1/1 Aggravated Battery to Fireman – 35 W. 34<sup>th</sup> St. A highly intoxicated subject was being transported to St. James Hospital in Olympia Field and Kneaded one of the fireman in the back of the head. Charges pending.
- 1/1 Criminal Damage to Property – 21100 Block of Jim Johnson Ln. Offender unknown damaged the exterior paint and flattened the front and rear passenger tires on the victim's Dodge Charger. Police are investigating.
