- 2/17 Domestic Disturbance 3300 Block of Morgan. Physical altercation between cohabitants. Conflicting statements, unable to substantiate complaints. Both parties were given information to obtain an Order of Protection.
- 2/17 Traffic Arrest 35th & Chicago Rd. Maria-G. Rondon-Valderrama, 41 of University Park was arrested for No Valid Driver's License and Suspended Registration. Rondon-Valderrama was cited and released. The offender's vehicle was towed and impounded.

The offender's vehicle was towed and impounded.
