- 1/11 Theft 300 Block of W. 34th St. Vehicle owner reported an unknown offender stole his registration sticker from his 2014 Hyundai.
- 1/11 Domestic Disturbance 3000 Block of Peoria St. Verbal altercation between mother and son. The son exited the building, and was locked out by the mother. The mother told police the son forced entry causing damage to the doorframe. Prosecution declined.
- 1/12 Domestic Battery 400 Block of W. 34th St. Victim reported she was involved in a verbal altercation with her boyfriend, Deveante O Bond, 24 of Chicago. The argument escalated, and Bond grabbed the victim around her neck and forced her to the bed. The victim told police she was choked, slammed to the floor, grabbed by her face and her mouth covered. The offender took her phone when she told him she was calling the police. The offender left prior to police arrival. Later that evening police were alerted that the offender was back at the apartment. Police made contact with Bond, and placed him into custody. Bond was processed and transported to the Will County Adult Detention Facility.
- 1/12 Domestic Disturbance 3100 Block of Union Ave. The Reporting Party told police his ex-girlfriend swung an alcohol bottle at him, but he was able to block her strike. The girlfriend was gone upon police arrival.
- 1/12 Domestic Dispute 3400 Block of S. Kings Rd. Verbal altercation between cohabitants. Father was concerned for the children's safety under the mother's care due to a text message he received. Steger FD evaluated the mother, who refused to be transported to the hospital. DCFS contacted and advised of the incident.
- 1/13 Domestic Dispute 3600 Block of Chicago Rd. Altercation between boyfriend and girlfriend. Parties separated, peace restored.

- 1/13 Welfare Check 3700 Block of Union Ave. Landlord told police she has not seen a tenant for two weeks and was concerned for his wellbeing. Police spoke to the tenant who no longer receiving social security, and having financial issues. Will County Senior Services contacted and will send an investigator.
- 1/13 Battery 22331 Cottage Grove Ave. School employee reported a student attempted to re-enter the school instead of getting on the bus. He told the student he cannot go back in the school. The student pushed the employee. TOT Juvenile Investigations.
- 1/13 Disturbance 3420 Union Ave. (Brick Oven Pizza). Subject, Donte D. Dupree, 57 of Crete entered the business and attempted to gain access to an employee only area. A staff member was threatened when he told Dupree he was not allowed in that area. Dupree was escorted from the property and issued a Trespass Notice.
- 1/13 Disturbance 3401 Chicago Rd. (7-Eleven). Two subjects, female and male entered the store. The female was in the store for approximately thirty minutes. The male entered and departed the store three times during the thirty minute time period. The subjects began yelling at the employee, which caused her to ask them to leave.
- 1/14 Criminal Sexual Abuse 3400 Block of S. Kings Rd. Victim reported being sexually abused by a family member. Police are investigating.
- 1/14 Criminal Trespass, Criminal Damage to Property 200 Block of Richton Rd. The reporting party told police, offender(s) unknown gained access to the vacant building. Police observed graffiti on the walls and extension cords, and a heater in one of the bedrooms. Police are investigating.
- 1/15 Theft 300 Block of W. 35th St. Offender unknown stole a package that was delivered by FedEx. The package valued at approximately \$1,600.00 was left in front of her apartment door. Report on file.
- 1/15 Criminal Trespass 201 E. 34th St. (Party Liquors). Kahil G. Banks, 35 of Chicago Heights entered the business and demanded a refund for a cigar he purchased three weeks ago. The employee advised Kahil to calm down, he was causing a disturbance. Kahil continued to yell after he was given a \$1.50 refund. Cahill was told to leave the store, at which time he threatened the employee. Police located the offender, advised him not to return to the business, and issued him a Trespass Notice.

- 1/15 Criminal Damage to Property 3400 Block of Halsted Blvd. While an Uber driver was picking up a female passenger, an unknown male subject with a facial tattoo, wearing a black hoodie approached the rear of the vehicle and broke the rear window with a black object. The female exited the vehicle and fled on foot. Police located a suspect, but the witness was unable to make positive identification. Police are investigating.
- 1/16 Aggravated Assault, Endangering the Life or Health of a Child 3700 Block of Sangamon St. Antonia A. Carrell, 40 of Steger was arrested for brandishing a knife and chasing 17 year old son. Carrell was processed and transported to the Will County Adult Detention Facility. DCFS notified.
- 1/16 Theft 100 Block of W. 34th St. Victim reported two wallets missing from her residence. Victim believes someone who was visiting may have taken her property.
- 1/16 Retail Theft 20 E. 34th St. (Party Liquors). Offender is captured on surveillance video removing bottles of tequila and boxes of cigars from the business without rendering payment. Police are investigating.
- 1/16 Domestic Disturbance 3100 Block of Green St. The victim told police he was sleeping on the couch and was awoken by his father. His father was yelling at him for no known reason. The victim said he took his dog for a walk to defuse the problem. Upon returning, he observed his father letting the air out of his vehicle tires. Police attempted to make contact with the father, but met with negative results. Parties separated.
