- 1/18 Criminal Trespass 430 W. 34<sup>th</sup> St. (PK's Pantry) Police responded to the business for a disturbance with a customer. Store employee reported the customer, Nina C. Wadlington, 36 of Steger was attempting to make a purchase but did not have enough money. Wadlington started yelling at the employee, and refused to leave. Wadlington was arrested for Criminal Trespass and Resisting Obstructing a Peace Officer. The offender was processed, provided a Will County Notice to Appear, and released.
- 1/18 Criminal Trespass, Aggravated Assault 3507 Chicago Rd. (Circle K Gas Station). James Burks, 32 of Steger was arrested for Criminal Trespass. During the arrest process, Burks threatened officers with bodily harm. Burks was additionally charged with Aggravated Assault.
