- 11/9 Traffic Arrest 3400 Block of Green St. Gary L. Brown, 49, of Crete was stopped for improper lane usage one way street. Upon checking the driver's status, it was revealed Brown's license was revoked. Brown was arrested, processed, given a Will County Notice to Appear, and released. The offender's vehicle was towed and impounded.
- 11/9 Domestic Dispute 100 Block of Dorsetshire Dr. Resident reported his son was banging and punching the walls. Parties were separated, peace restored.

- 11/9 Criminal Trespass 400 Block of W. 34th St. Resident reported, when she returned to her apartment she found items that did not belong to her. There was no signs of forced entry, and the victim told police she did not give a key to anybody else. A report will be filed with apartment staff.
