- 12/21 Child Custody Dispute, Welfare Check – 3600 Block of Halsted Blvd. Police were contacted by the mother, who told police she dropped her child off with the father. The mother was worried about the child getting her medication. The child's father sent a text message to the mother advising the child was okay. Mother was advised to seek court order for visitation.
