The Board of Trustees convened in regular session at 7:00 P.M. on this 21st day of April 2025 in the Municipal Building of the Village of Steger, Illinois. Interim Mayor Joyce led all in attendance in the Pledge of Allegiance to the flag.

The roll was called. The following Trustees were present; Thurmond, Stewart, Trotier, Joyce and Perchinski. Trustee Lopez was absent.

Also present: Village Administrator Mary Jo Seehausen, Director of Public Infrastructure Dave Toepper, Fire Chief Mike Long, Police Chief Greg Smith, EMA Chief Jason Stevenson and Community Center Director Diana Rossi.

Trustee Stewart made a motion to approve the minutes of April 7th meeting as all members have copies. Trustee Perchinski seconded the motion.

REPORTS

Village Administrator Mary Jo Seehausen Just a couple of things. Representative Deluca will be hosting his annual barbeque in Steger this year. It's going to be on July 11th, they will have more information out on that shortly, and as soon as I have it I will distribute it and get it on social media.

We will have Misericordia holding Candy Days this upcoming weekend on the 25th and 26th. They have approval to stand in front of Party Liquors and St. Liborius Church. I asked and received a list of people that will be doing this and shared it with our Police Department.

Also, the renewal rates for our Medical Insurance came in: We will be seeing a 16.10% increase on our PPO and a 7.60% increase on our HMO policy this year.

Director of Public Infrastructure Dave Toepper For the month of March, the Department of Public Works and the Building Department have done 160 locates, and

repaired 7 water main breaks. Building Department and Code Enforcement have made 100 Resident contacts, issued 40 – 48 hour notices, 15 Citations, 18 Re-occupancy Inspections, 28 Building Permit inspections and has issued 36 new Building Permits.

Fire Chief Mike Long For the month of March we ran a total of 180 calls; 134 medical and 46 fire. Other than that, I want to thank everyone who came out for our Easter Egg Hunt. We had a good showing this year, and all the kids seemed to have a good time.

Police Chief Greg Smith Our monthly Police Log was Psychology of Domestic Violence. DC Fajman and myself attended Aunt Martha's meeting with their new representative. DC Fajman and myself also attended a meeting on first Responder Priority. DC Fajman attended the monthly LCC meeting. Sergeant Hillman and Officer Brian Smith attended the ILETA conference for our trainers, to keep them certified. Detective Darge attended the ID Away Drug Conference, and our new recruits are to attend their power test tomorrow.

**AN ORDINANCE AMENDING CHAPTER 82, SECTION 82-479 OF THE
MUNICIPAL CODE OF STEGER, ILLINOIS REGARDING PARKING
RESTRICTIONS ON 34TH PLACE AND ROYAL OAKS DRIVE IN
THE VILLAGE OF STEGER, ILLINOIS**

WHEREAS, the Village of Steger, located in the Counties of Cook and Will, State of Illinois (the "Village"), is a duly organized and existing municipality operating under the Illinois Municipal Code and other applicable laws, with full authority to enact ordinances and adopt resolutions to promote the public health, safety, and welfare of its residents; and

WHEREAS, the Village President (the "President") and the Board of Trustees of the Village (the "Village Board" and with the President, the "Corporate Authorities") are committed to maintaining the safe, efficient, and orderly use of Village streets and ensuring that parking regulations are reasonable, enforceable, and responsive to the needs of the community; and

WHEREAS, Section 11-208 of the Illinois Vehicle Code (625 ILCS 5/11-208) grants municipalities the authority to regulate the standing or parking of vehicles on streets and highways under their jurisdiction; and

WHEREAS, the Steger Municipal Code (the "Village Code") currently contains provisions regulating parking within the Village (the "Existing Regulations"); and

WHEREAS, the Corporate Authorities have reviewed the Existing Regulations and determined that certain modifications are warranted to improve traffic flow, facilitate access for emergency vehicles, enhance public safety, and better serve the needs of the community; and

WHEREAS, in furtherance of these objectives, the Corporate Authorities have determined that it is necessary and appropriate to: (1) prohibit parking on 34th Place between Emerald Avenue and Chicago Road at all times; and (2) prohibit overnight parking on Royal Oaks Drive between the hours of 11:30 p.m. and 4:00 a.m.; and

WHEREAS, the Corporate Authorities find that these changes are in the best interests of the Village and its residents and that Chapter 82, Section 82-479 of the Village Code should be amended accordingly;

NOW, THEREFORE, BE IT ORDAINED by the President and the Board of Trustees of the Village of Steger, Counties of Cook and Will, and the State of Illinois, as follows:

ARTICLE I. IN GENERAL

SECTION 1.0: Recitals Incorporation.

The Corporate Authorities hereby find that the recitals set forth above are true and correct and hereby incorporate them into this Ordinance as legislative findings by this reference.

SECTION 2.0: Purpose.

The purpose of this Ordinance is to amend Chapter 82, Section 82-479 of the Village Code as set forth below.

ARTICLE II. AUTHORIZATION

AMENDMENT OF CHAPTER 82, SECTION 82-479 OF THE MUNICIPAL CODE FOR THE VILLAGE OF STEGER, ILLINOIS

SECTION 3.0: Amendment to Chapter 82, Section 82-479 of the Village Code.

Notwithstanding any provision, ordinance, resolution or section of the Village Code to the contrary, Chapter 82, Section 82-479 of the Municipal Code of Steger,

Illinois is hereby amended to read as follows, with additions shown as underlined and deletions shown as strikethrough:

Sec. 82-479. Parking prohibited on certain streets.

- (a) It shall be unlawful for any person to park any vehicle at any time on either side of 35th Street between Johns Street and Kings Road in the village.
- (b) It shall be unlawful for any person to park any vehicle at any time on the south side of 30th Street between the C. & E. I. Railroad and Carpenter Street in the village.
- (c) It shall be unlawful for any person to park any vehicle at any time on either side of Kings Road between Steger Road and 35th Street in the village.
- (d) It shall be unlawful for any person to park any vehicle at any time on the west side of Lewis Street between Steger Road and 35th Street in the village.
- (e) It shall be unlawful for any person to park any vehicle at any time on the north side of McKinley Avenue between Emerald Avenue and Chicago Road.
- (f) It shall be unlawful for any person to park any vehicle at any time on 34th Place between Emerald Avenue and Chicago Road.
- (g) It shall be unlawful for any person to park any vehicle overnight between 11:30 p.m. and 4:00 a.m. on either side of Royal Oaks Drive.

SECTION 3.1: Other Actions Authorized.

The officers, employees and agents of the Village shall take all actions necessary or reasonably required to implement and carry out the provisions of this Ordinance and to effectuate the amendment set forth herein. Such actions shall include, without limitation, the preparation and dissemination of any forms, notices, vehicle stickers, or other materials necessary to enforce and administer the parking regulations established by this Ordinance.

**ARTICLE III.
HEADINGS, SAVINGS CLAUSES, PUBLICATION,
EFFECTIVE DATE**

SECTION 4.0: Headings.

The headings of the articles, sections, paragraphs and subparagraphs of this Ordinance are inserted solely for convenience of reference and form no substantive part of this Ordinance, nor should they be used in any interpretation or construction of any substantive provision of this Ordinance.

SECTION 5.0: Severability.

The provisions of this Ordinance are hereby declared to be severable and should any provision of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, such provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein, and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

SECTION 6.0: Superseder.

All prior ordinances, resolutions, rules, orders, or parts thereof, in conflict with this Resolution are hereby repealed to the extent of such conflict.

SECTION 7.0: Publication.

A full, true and complete copy of this Ordinance shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

SECTION 8.0: Effective Date.

This Ordinance shall be in full force and effect ten (10) days after its passage, approval and publication in accordance with applicable law.

**RESOLUTION AUTHORIZING THE EXECUTION OF A LAW ENFORCEMENT
MUTUAL AID AGREEMENT AND THE EXISTENCE AND FORMATION OF THE
ILLINOIS LAW ENFORCEMENT ALARM SYSTEM BY INTERGOVERNMENTAL
COOPERATION FOR THE VILLAGE OF STEGER.**

WHEREAS, the Village of Steger, Counties of Cook and Will, State of Illinois (the "Village") is a duly organized and existing municipality and unit of local government created under the provisions of the laws of the State of Illinois, and is operating under the provisions of the Illinois Municipal Code, and all laws amendatory thereof and supplementary thereto, with full powers to enact ordinances and adopt resolutions for the benefit of the residents of the Village; and

WHEREAS, the Village, as a public agency of the State of Illinois, is authorized and empowered by the Constitution of the State of Illinois (Ill. Const. Art. VII, § 10) and the Illinois Intergovernmental Cooperation Act (5 ILCS 220/1, *et seq.*) to enter into intergovernmental agreements with other public agencies on matters of mutual concern and interest such as the provision of adequate law enforcement personnel and resources for the protection of residents and property falling within the jurisdiction of the Village; and

WHEREAS, the Village President (the "President") and Board of Trustees of the Village (the "Village Board" and together with the President, the "Corporate Authorities") are committed to ensuring the welfare and safety of the Village and its residents; and

WHEREAS, the Village recognizes that certain natural or man-made occurrences may result in emergencies or disasters that exceed the resources, equipment and/law enforcement personnel of a single given public agency; and

WHEREAS, a given public agency can, by entering into a mutual aid agreement for law enforcement services and resources, effectively provide a broader range and more plentiful amount of law enforcement capability for the citizenry which it serves; and

WHEREAS, in order to have an effective mutual aid agreement for law enforcement resources and services, this Village recognizes it must be prepared to come to the aid of other public agencies in their respective times of need due to emergencies or disasters; and

WHEREAS, the Village recognizes the need for the Village to develop an effective mutual aid agreement for law enforcement services and resources upon which it may call in its time of need and is prepared to enter into a mutual aid agreement for law enforcement services and resources with other like-minded public agencies; and

WHEREAS, the Village also recognizes the need for the existence of a public agency, formed by an intergovernmental agreement between two or more public agencies, which can serve to coordinate and facilitate the provision of law enforcement mutual aid between signatory public agencies to a mutual aid agreement for law enforcement services and resources; and

WHEREAS, the Village has been provided with a certain "Suburban Mutual Assistance Response Team (SMART)" agreement (the "Agreement") which has been reviewed by the Corporate Authorities and which other public agencies in the State of Illinois are prepared to execute, in conjunction with the Village, in order to provide and receive law enforcement mutual aid services as set forth in the Agreement; and

WHEREAS, it is the anticipation and intention of the Village that the Agreement will be executed in counterparts as other public agencies choose to enter into the Agreement and strengthen the number of signatory public agencies and resources available from those public agencies; and

WHEREAS, it is the anticipation and intent of the Village that the Agreement will continue to garner support and acceptance from other currently unidentified public agencies who will enter into the Agreement over time and be considered as if all signatory public agencies to the Agreement had executed the Agreement at the same time; and

WHEREAS, in connection with the foregoing, the Corporate Authorities have determined that it is necessary and in the best interests of the Village to adopt the Agreement as set forth on Exhibit A, attached hereto and incorporated herein; and

NOW, THEREFORE, BE IT RESOLVED by the President and the Board of Trustees of the Village of Steger, Counties of Cook and Will, and the State of Illinois, as follows:

ARTICLE I. IN GENERAL

SECTION 1: Incorporation Clause.

The Corporate Authorities hereby find that all of the recitals hereinbefore stated as contained in the preambles to this Resolution are full, true and correct and do hereby, by reference, incorporate and make them part of this Resolution as legislative findings.

SECTION 2: Purpose.

The purpose of this Resolution is to adopt the "Suburban Mutual Assistance Response Team (SMART)" Agreement, as set forth on Exhibit A, to authorize the President or his designee to take such steps as are necessary to carry out the intent

of this Resolution and to ratify any actions previously taken that are consistent with the intent of this Resolution.

ARTICLE II. AUTHORIZATION

SECTION 3: Authorization.

The President is hereby authorized to sign, execute and deliver the Agreement and thereby enter into an intergovernmental agreement with such other public agencies of the State of Illinois as are likewise willing to enter into said Agreement and recognize the existence and formation of the Illinois Law Enforcement Alarm System. The officers, employees, and/or agents of the Village shall take all action necessary or reasonably required by the Village to carry out, give effect to, and consummate the intent of this Resolution. Any and all actions previously performed in connection with carrying out and consummating the intent of this Resolution are hereby authorized, approved and ratified by this reference. The Village Board further authorizes and directs the President, or his designee, to execute the Agreement, with such insertions, omissions and changes as shall be approved by the President and the Attorney. The Village Clerk is hereby authorized and directed to attest to and countersign the Agreement and any other documentation as may be necessary to carry out and effectuate the purpose of this Resolution. The Village Clerk is also authorized and directed to affix the Seal of the Village to such documentation as is deemed necessary. The officers, agents and/or employees of the Village shall take all action necessary or reasonably required by the Village to carry out, give effect to and effectuate the purpose of this Resolution and shall take all action necessary in conformity therewith. In addition to the foregoing, the President, or his designee, is hereby given the authority to enter into any additional agreements and undertake any additional obligations in conformity therewith.

**ARTICLE III.
HEADINGS, SAVINGS CLAUSES, PUBLICATION,
EFFECTIVE DATE**

SECTION: 4 Headings.

The headings of the articles, sections, paragraphs, and subparagraphs of this Resolution are inserted solely for convenience of reference and form no substantive part of this Resolution nor should they be used in any interpretation or construction of any substantive provision of this Resolution.

SECTION: 5 Severability.

The provisions of this Resolution are hereby declared to be severable and should any provision of this Resolution be determined to be in conflict with any law, statute, or regulation by a court of competent jurisdiction, said provision shall be excluded and deemed inoperative, unenforceable, and as though not provided for herein, and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

SECTION: 6 Superseder.

All code provisions, ordinances, resolutions, rules, and orders, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby superseded.

SECTION: 7 Publication.

A full, true, and complete copy of this Resolution shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

SECTION: 8 Effective Date.

This Resolution shall be effective and in full force immediately upon passage and approval.

SUBURBAN MUTUAL ASSISTANCE RESPONSE TEAM
(SMART)

Mutual Aid Agreement

These Articles of Agreement, made and entered into on the ____ day of _____, A.D., 20____, by and between all the participating municipalities/organizations that have approved and adopted, in the manner as provided by law and are herein listed at the end of this agreement.

Section One - Purpose

The purpose of this Agreement is to provide for a program of Mutual Aid between all of the participating municipalities whereby the Aiding Municipalities will respond to the Stricken Municipality with such equipment and manpower as has been predetermined by the Emergency Management Agency/Emergency Services and Disaster Agency Coordinator of each municipality through the Mutual Aid Box System.

Section Two - Definitions

For the purpose of this Agreement, the following terms are defined as follows:

- A. "Municipality": A city, village, township, or other jurisdiction having an Emergency Management Agency (EMA) or Emergency Services and Disaster Agency (ESDA).
- B. "Mutual Aid": A definite and pre-arranged written agreement and plan whereby regular response and assistance is provided for in event of an emergency or disaster in a stricken municipality by the aiding municipalities in accordance with the assignments as developed by the Emergency Services Coordinator of the participating municipality.
- C. "Participating Municipalities": A municipality that commits itself to this Mutual Aid Agreement by adopting a Resolution/Ordinance authorizing participation in the program with other participating municipalities for rendering and receiving mutual aid in the event of an emergency or other disaster in accordance with the 1975 Emergency Services and Disaster Agency (ESDA) Act of Illinois, as amended.
- D. "Stricken Municipality": The municipality in which an emergency or other disaster occurs that is of such a magnitude that it cannot be handled adequately by the local municipality.
- E. "Aiding Municipality": A municipality furnishing equipment and manpower to a stricken municipality.

Section Three - Agreement to Effectuate the Mutual Aid Plan

The Village President, Mayor, or Board of Trustees of each participating municipality is authorized on behalf of that municipality to enter into and from time to time alter/amend, on the advice of the E.M.A./E.S.D.A. Coordinator and with the consent of the governing body of that municipality, an agreement with other municipalities for mutual aid according to the following:

1. Whenever an emergency or disaster is of such magnitude and consequence that it is deemed advisable, by the senior officers present of that stricken municipality, to request assistance of the aiding municipalities, he/she is hereby authorized to do so under the terms of this mutual aid agreement, and the senior officers present of the aiding municipalities are authorized to and shall take the following action:
 - a. Immediately determine what equipment is required according to the Mutual Aid Box System.
 - b. Immediately determine if the required equipment and personnel can be committed in response to the request from the stricken municipality.
 - c. Dispatch immediately the equipment required to the stricken municipality in accordance with the Mutual Aid Box System.
2. The rendering of assistance under the terms of this Mutual Aid Agreement shall not be mandatory in accordance with the box system if local conditions prohibit response. In that event, it is the responsibility of the aiding municipality to immediately notify the stricken municipality of same.

It shall be agreed that denial by any party to this agreement to render aid when requested, if for good reason or cause, shall not be grounds for termination of this agreement.
3. All of the participating municipalities agree to waive all claims against the other party or parties for compensation for any loss, damage, personal injury or death occurring in consequence of this mutual aid agreement. General liability insurance, personal injury and property damage insurance against loss or damage of equipment is the responsibility of each participating municipality as it applies to their own manpower and equipment. All services performed under this mutual aid agreement shall be rendered without reimbursement to any municipalities.

4. It is hereby understood and agreed that the Senior Officer in whose community the emergency exists, and who placed the request for aid, shall in all instances be in command of the emergency as to the aspects of overall direction of the operation. They will assign Senior Officer(s), and equipment, of the aiding municipalities to positions when and where they deem necessary. It shall be agreed that all elements responding to the request for aid under the terms of this agreement shall be under the direct command of their own officer(s). All orders or directions regarding the operations of the responding elements to the emergency shall be relayed to the officer(s) in command of the responding elements. Directing of operational strategy during the emergency may be delegated by the Senior Officer in charge of the emergency to the officer(s) in command of the responding elements, insofar as their part of the operations is concerned. In any instance where the question of command responsibility should arise, all elements of parties to this agreement are requested to cooperate fully, one with another, in an attempt to carry out the spirit and purpose of this agreement as entered into.
5. It shall be the responsibility of the Senior Officer of each party of this agreement to assure the fact that all personnel responding under the terms of this pact for emergency assistance shall be recognized representatives of that communities Emergency Services Organization, and that the conduct and actions of said personnel shall be the responsibility of the community sending aid.
6. All requests for emergency assistance shall be made only through the Central Communications Dispatch of each community, or Suburban Mutual Assistance Response Team box system, and not through subordinate command channels.
7. It shall be agreed that the responding parties to this agreement shall honor the terms of this agreement regarding the operation of units in the field, and at the designated locations, for as long as is required, except that the responding department may, at its own discretion upon orders of its own officer(s) in command or upon orders of its Director, withdraw its equipment and personnel at any time it deems appropriate,--and for its own reasons,-- provided however, that the officer(s) in command shall first notify the appropriate officer in charge of the operation or location in order to provide him/her with the opportunity of securing replacements for the void that may be created by the withdrawal.
8. This agreement is intended to cover day-to-day mutual aid only, and shall be of no force and effect in cases in which a state of extreme emergency has been proclaimed and when the Illinois Emergency Services Master Aid Agreement(s) become operative.
9. The E.M.A./E.S.D.A. Coordinator, officers and personnel of all participating municipalities are invited and encouraged to visit frequently each other's facilities for familiarization tours, and jointly to conduct training sessions and hypothetical disaster

exercises.

Section Four - Termination

Any municipality may withdraw from the Suburban Mutual Assistance Response Team Mutual Aid Agreement by notifying the other participating municipalities in writing. Whereupon, the withdrawing municipality will terminate participation thirty (30) days from the date of the written notice.

Section Five - Duration

It shall be agreed that this agreement shall be in force from its agreement date forward without a terminal date, unless the terms of Section Four are invoked.

Section Six - Amendments

This agreement may be called up for review and amended by any party at any time agreeable to the majority of the parties.

Section Seven - Adoption

This Mutual Aid Agreement shall be in full force and effect with the passage and approval of a companion Resolution/Ordinance by all participating municipalities/organizations in the manner provided by law, and the signing of this Agreement by the Village President, City Mayor, and/or Trustees of said municipal jurisdiction.

INDIVIDUALS TO ACT AS AUTHORIZED SIGNATORIES ON VILLAGE OF
STEGER ACCOUNTS HELD AT OLD PLANK TRAIL COMMUNITY BANK**

WHEREAS, the Village of Steger, located in the Counties of Cook and Will, State of Illinois (the "Village"), is a duly organized and existing municipality operating under the Illinois Municipal Code and other applicable laws, with full authority to enact ordinances and adopt resolutions for the benefit of its residents; and

WHEREAS, the Village maintains financial accounts at Old Plank Trail Community Bank (the "Bank") for the deposit, management, and disbursement of Village funds; and

WHEREAS, the Village President (the "President") and Board of Trustees of the Village (the "Village Board" and together with the President, the "Corporate Authorities") seek to ensure efficient fiscal operations and accountability by designating specific Village officials and employees to act as authorized signatories on these accounts; and

WHEREAS, the Corporate Authorities previously designated Kenneth A. Peterson, Jr. as an authorized signatory, but he is now deceased; and

WHEREAS, the Village seeks to update its list of signatories by removing Kenneth A. Peterson, Jr. and appointing William J. Joyce, Village President, as a replacement, while retaining the existing signatories: Joseph M. Zagone, Jr., Village Clerk and Mary Jo Jasinski Seehausen, Village Administrator;

NOW, THEREFORE, BE IT RESOLVED by the President and the Board of Trustees of the Village of Steger, Counties of Cook and Will, and the State of Illinois, as follows:

**ARTICLE I.
IN GENERAL**

SECTION 1: Recitals Incorporation.

The Corporate Authorities hereby find that the facts and statements contained in the preamble to this Resolution are true and correct and, by this reference, are incorporated herein as findings of the Corporate Authorities.

SECTION 2: Purpose.

The purpose of this Resolution is to update and authorize William J. Joyce, Village President to act as signatory, along with the existing signatories: Joseph M. Zagone, Jr., Village Clerk and Mary Jo Jasinski Seehausen, Village Administrator, on the Village's accounts with the Bank, to authorize the President or his designee to take such steps as are necessary to carry out the intent of this Resolution and to ratify any actions previously taken that are consistent with the intent of this Resolution.

**ARTICLE II.
AUTHORIZATION**

SECTION 3: Authorization.

The Village Board hereby authorizes and designates the following individuals to act as signatories on behalf of the Village for any or all accounts maintained at the Bank:

- William J. Joyce, Village President
- Joseph M. Zagone, Jr., Village Clerk
- Mary Jo Jasinski Seehausen, Village Administrator

Each of the above-listed individuals is authorized to sign checks, drafts, and other instruments for the withdrawal or transfer of Village funds, and to otherwise take actions necessary to manage the Village's accounts at the Bank.

SECTION 4: Implementation.

The Village President, or his designee, is authorized to execute any documents necessary to implement this Resolution. The Village Clerk is authorized to attest, countersign, and affix the corporate seal to such documents as needed. All officers, agents and employees of the Village are hereby directed to take any or all actions necessary or appropriate to carry out the intent and purpose of this Resolution.

**ARTICLE III.
HEADINGS, SAVINGS CLAUSES, PUBLICATION,
EFFECTIVE DATE**

SECTION 5: Headings.

The headings of the articles, sections, paragraphs, and subparagraphs of this Resolution are inserted solely for convenience of reference and form no substantive part of this Resolution, nor should they be used in any interpretation or construction of any substantive provision of this Resolution.

SECTION 6: Severability.

The provisions of this Ordinance are hereby declared to be severable and should any provision of this Ordinance be determined to be in conflict with any law, statute or regulation by a court of competent jurisdiction, such provision shall be excluded and deemed inoperative, unenforceable and as though not provided for herein, and all other provisions shall remain unaffected, unimpaired, valid and in full force and effect.

SECTION 7: Superseder.

All prior ordinances, resolutions, rules, orders, or parts thereof, in conflict with this Resolution are hereby repealed to the extent of such conflict.

SECTION 8: Publication.

A full, true, and complete copy of this Resolution shall be published in pamphlet form or in a newspaper published and of general circulation within the Village as provided by the Illinois Municipal Code, as amended.

SECTION 9: Effective Date.

This Resolution shall be in full force and effect immediately upon passage and approval.
