- 2/22 Criminal Damage to Property – 300 Block of W. 35<sup>th</sup> St. Victim reported damage to her 2011 Volkswagen. Offender unknown slashed her right rear tire.
- 2/24 Harassment through Electronic Communications – 100 W. Richton Rd. Representative of a non-profit organization that provides donated items to people in need of assistance. Two people came in advising they were homeless and needed assistance. The organization provided items, including a three hundred dollar jacket. The Representative discovered the subjects were trying to sell the jacket. The subjects were advised they will no longer receive assistance from the organization. The subject began harassing and threatening the Representative via social media, text messages, and phone calls. Report on file.
- 2/24 Theft of Motor Vehicle Parts – 3420 Chicago Rd. (LB's Discount Auto Sales). Offender unknown removed the catalytic convertors from a 2006 Jeep Liberty. The business representative was unable to provide a time frame for the theft.
- 2/24 Retail Theft – 3401 Chicago Rd. (7-Eleven). Myles E. Johnson, 29 of Chicago Heights removed items without making payment. Johnson was issued a Trespass Notice, Local Ordinance Citation for Retail Theft, and Cook County Citation for Public Intoxication. Johnson was provided an escort to Chicago Heights.
- 2/24 Domestic Disturbance – 400 Block of W. 34<sup>th</sup> St. Resident reported she was involved in a verbal altercation with her ex-boyfriend. During the altercation a vase was broken. Prosecution declined, parties separated, peace restored.
- 2/25 Burglary to Motor Vehicle – 20 E. 34<sup>th</sup> St. (Party Liquors). The victim parked her 2019 Kia in the parking lot and entered the business. Upon returning to her vehicle she discovered an unknown offender entered her unsecured vehicle and stole her cell phone. TOT Investigations.

- 2/25 Domestic Disturbance – 3600 Block of Chicago Rd. Verbal altercation between cohabitants.
- 2/26 Burglary – 3325 Chicago Rd. (Little Caesars). Three male subjects wearing masks broke a window gaining access to the business. The offenders stole an undetermined amount of change. Police are investigating.
