- 3/1 Disturbance – 3000 Block of Halsted. Police responded to the residence for a report of a disturbance involving an intoxicated subject. Upon arrival the Reporting Party told police her brother showed up intoxicated and she did not want him in the house. When the subject attempted to leave she took his keys. The subject was transported to St. James Hospital in Olympia Fields by the South Chicago Heights Fire Department.
- 3/1 Domestic Disturbance – 3400 Block of S. Kings Rd. Verbal altercation between boyfriend and girlfriend. Female refusing to give her boyfriend his personal property. Police stood by until the property was transferred to the boyfriend. Parties separated, peace restored.
- 3/2 Domestic Disturbance – 3500 Block of Williams St. Altercation between boyfriend and girlfriend. The female party was attempting to gather her personal belongings and leave. Altercation escalated and became physical. Conflicting statements, unable to substantiate complaints. Police stood by until female gathered property and departed. Female party was advised to contact police before returning for her remaining property.
- 3/2 Delayed Domestic Battery – 100 Block of E. 34th St. Victim reported her ex-boyfriend, Christopher J. Stumber, 41 of Chicago heights came over and broke her ceiling light in the kitchen. The victim told police, the offender slapped her, punched her in the head, choked her, and pulled her hair. Police did not observe any injuries, but offered to contact EMS. The victim declined medical service. Information was provided to obtain an Order of Protection. South Chicago Heights conducted a traffic stop on Stumber, Stumber was arrested for three outstanding Cook County Warrants.
- 3/3 Attempt Motor Vehicle Theft, Criminal Damage to property – Offender unknown gained entry into the victim's secured 2023 Toyota Highlander . The victim was unable to identify any missing items. TOT Investigations.

- 3/4 Parent-Juvenile Crisis Intervention – 3400 Block of Phillips. Parent reported having discipline problems with juvenile daughter. TOT Juvenile Investigations, and DCFS.
- 3/4 Assault – Warrant Arrest – A subject working for a real estate business was taking pictures of a house, when confronted by a neighbor. The neighbor mistakenly thought the subject was taking pictures of her house, and a verbal altercation ensued. Offender, Kenneth A. Culvers, 48 of Steger was driving by and observed the altercation. Culver exited his vehicle and confronted the real estate employee while he was seated in his car. The two were involved in an argument, when the offender attempted to punch the other party. Prosecution declined. Upon conducting a record check on all subjects, it was discovered that Culvers had an outstanding warrant. Culvers was arrested, and transported to the Will County Adult Detention Facility.
- 3/5 Attempt Motor Vehicle Theft – 3400 Block of Peoria St. Offender(s) unknown broke the passenger side window on the victim's 2021 Kia, gaining entry. The offender(s) damaged the steering column in their attempt to steal the vehicle. TOT Investigations.
- 3/5 Attempt Motor Vehicle Theft – 3600 Block of Sangamon St. Offender(s) unknown broke the rear driver side window to gain access into the victim's 2024 Kia Forte. The steering column was damaged during the attempt to steal the vehicle TOT Investigations.
- 3/5 Attempt Motor Vehicle Theft – 3500 Block of Morgan St. Offender(s) unknown broke the rear driver side window on the victim's 2025 Hyundai. Nothing was reported missing. Police are investigating.
- 3/6 Harassment through Electronic Communications – 3000 Block of Phillips Ave. Victim reported being harassed on Facebook. Report on file.
- 3/6 Burglary to Motor Vehicle – 3400 Block of Susan Ln. Report of a male subject wearing a black hoodie attempting to break into the victim's vehicle. The subject broke the rear passenger side window on the victim's 2020 KIA Forte and removed property belonging to the victim. The offender, identified as Calvin K. Hodge, 19 of Chicago was detained nearby. The offender was positively identified by the victim. The offender was charged with Burglary, Possession of Burglary Tools, and Criminal Damage to Property. Hodge was processed, provided a Will County Notice to Appear, and released.

3/7 Burglary to Motor Vehicle – 300 Block of W. 35th St. Offender(s) unknown entered the victim's 2020 Hyundai Tucson and removed an undetermined amount of change. The steering column was also damaged during the time of the incident. Police are investigating.

3/7 Domestic Disturbance – 300 Block of W. 35th St. Altercation between boyfriend and girlfriend. Conflicting statements, unable to substantiate complaints. The female party requested an ambulance. Subject was transported to St. James Hospital in Olympia Fields by SFD.
