- 3/22 Domestic battery – 3000 Block of Peoria St. Police responded to the residence for a report of Domestic Battery. The offender, Taylor L. Jackson, 27 of Richton pushed her mother (victim), causing her to fall and bust her mouth on a living room end table. Jackson was transported to the Steger Police Department, processed and transported to the Cook County Adult Detention Facility.
- 3/22 Suspicious Circumstances – 3400 Block of Sally Dr. Resident discovered a gun magazine in his backyard. The property was tagged and placed into evidence. It is unknown how long the magazine has been on the property.
- 3/22 Theft – 3500 Block of Union Ave. Offender unknown stole the registration off of the victim's work vehicle. The license plate was entered into the Law Enforcement Agencies Data System as stolen. The license plate was recovered by the South Elgin Police Department.
- 3/23 Retail Theft – 430 W. 34th St. (PK's Pantry). Offender unknown entered the business, removed a half gallon of wine and departed without making payment. Police are investigating.
- 3/23 Domestic Battery – 400 Block of W. 34th St. Victim told police her ex-boyfriend came over to retrieve items. The victim told her ex-boyfriend she could not find his phone. The offender kicked in her apartment door and attacked the victim. The offender was gone upon police arrival. Information provided to obtain an Order of Protection. Police are investigating.
- 3/24 Domestic Battery – 3700 Block of Crescent Dr. Physical altercation between family members (Mutual Combatants). Conflicting statement, unable to substantiate complaints.

- 3/24 Deceptive Practice – 300 Block of Columbia Circle. Victim received a text, followed by a phone call from a person enquiring about her bank account. The victim provided information before she realized it was a scam. The offender was able to withdraw \$600.00 from the victim's account.
- 3/24 Domestic Disturbance – 0-100 Block of E. 227th St. Verbal altercation between cohabitants. Wife took the husband's phone and refused to return it. Police mitigated a peaceful resolution. The phone was returned and both parties agreed to stay in different parts of the house.
- 3/24 Disorderly Conduct – 20 E. 34th St. (Party Liquors). Patron brought several items, including a box of wine to the register. The employee requested identification to verify her age. The customer became irate, told the employee she did not have identification. The offender then threw multiple items of merchandise on the floor and exited the business.
- 3/24 Suspicious Circumstances – 3507 Chicago Rd. (Circle K/Shell). Employee's reported a subject came in wearing a Brink's Security Officer Uniform. The subject attempted to use a key and pin but was unable to open the safe. The manager spoke to the subject, via telephone. The manager advised the subject they use a different company and told the subject to leave. The subject left without incident. Police are investigating.
- 3/25 Neighborhood Dispute– 0-100 Block of W. 31st St. Police were dispatched to the area for a Neighborhood Complaint. Police spoke to both parties. Resident in the area was upset because the minor was walking her dog in the alley. The resident complained the dog goes to the bathroom on village property he maintains. The resident identified as Mike Summa, 64 of Steger was issued a Local Ordinance Citation for Disorderly Conduct for threatening the juvenile.
- 3/26 Deceptive Practice – 400 Block of W. 34th St. Victim was on INSTAGRAM conversing with someone she believed to be an old schoolmate. The subject asked for money, the victim sent \$150.00.
- 3/26 Criminal Damage to Property – 400 Block of W. 34th St. Victim discovered someone slashed her rear driver side tire while it was parked in the apartment complex parking lot.
- 3/26 Harassment through Electronic Communications – 3200 Block of Morgan St. Victim reported receiving harassing text messages from her child's father.

- 3/27 Traffic Arrest – 34th & Union Ave. Moussa M. Leye, 24 of University Park was stopped for speeding, 65 mph in a posted 30 mph zone. Leye was cited and released on a Notice to Appear.
- 3/28 Traffic Arrest – 34th & Chicago Rd. Toshiva R. Walker, 30 of Steger was stopped for speeding. The offender was cited for Speeding, Driving on a Suspended License, and Operation of Uninsured Motor Vehicle. Walker was provided a Pre-Trial Notice to Appear, and released.
- 3/28 Traffic Arrest – 20 W. 34th St. Thomas G. Hayes, 67 of Steger, was stopped for speeding. The offender was cited for Speeding, Driving on a Suspended License, and Operation of Uninsured Motor Vehicle. Hayes was provided a Pre-Trial Notice to Appear, and released.
- 3/28 Motor Vehicle Theft – 300 Block of Columbia Circle. The victim left his secured vehicle parked and unattended for approximately six hours. When he returned he discovered his 2017 Hyundai Sedan was stolen. Police canvassed the area, and viewed Flock camera footage. The vehicle was recovered in Calumet City.
- 3/28 Aggravated Discharge of a Firearm – 3327 Chicago Rd. Police were dispatched to the business reference a shooting report. A witness described a dark gray four door sedan, with multiple occupants suspected of being involved in the shooting. Police spoke to patrons, who advised the shooting occurred in the parking lot. Police canvassed the area, identified and collected evidence. There were no injuries reported in connection with this incident. Police are investigating.
