Stumber was escorted off of the property and told not to return or he would be arrested for trespass. Police responded back to the address a short time later for a report of Stumber banging and kicking the door. Stumber was taken into custody for Criminal Trespass, transported to the police department, and processed. Stumber was provided a Will County Pre-Trial Notice to Appear, and provided a ride to his residence in Chicago Heights.
- 4/12 Telephone Harassment 0-100 Block of 30th St. Victim reported receiving numerous harassing telephone calls from her ex-boyfriend. Information was provided to obtain an Order of Protection.
- 4/12 Theft 3400 Block of Kings Rd. Offender unknown took a package that was delivered, and placed by the exterior apartment door.
