Upon arrival police observed the subject wearing only a shirt and underwear holding a firearm. Police ordered the subject to place his weapon on the ground, and the subject complied. The subject was transported to St. James Hospital in Olympia Fields. The weapon was taken for safekeeping. 5/5 Disorderly Conduct – 3000 Block of Wallace Ave. While speaking to juveniles a subject caused a breach of the peace, threatening bodily harm. A Local Ordinance citation was issued for Disorderly Conduct, peace restored. Domestic Dispute – 3400 Block of Kings Rd. Altercation between the victim and 5/6 his estranged wife.
