- 5/18 Domestic Crisis Intervention – 3200 Block of Chicago Rd. Verbal altercation between cohabitants. One of the involved parties agreed to leave for the evening, peace restored.
- 5/18 Unwanted Subject – 3700 Block of Stella Ave. Residents reported an acquaintance entered their residence without permission. The offender, Elsie A. Ziemann, 58 of Park Forest was told to leave, but she refused. Ziemann was issued a Trespass Notice and provided an escort to her residence.
- 5/18 Domestic Crisis Intervention – 3000 Block of Peoria St. Resident reported she was involved in a verbal dispute with her intoxicated son. Parties separated, peace restored.
- 5/18 Disturbance – 3300 Block of Butler Ave. Altercation between acquaintances. Friends broke up the altercation before it escalated. Parties separated, peace restored.
- 5/18 Residential Burglary – 300 Block of W. 35th St. The victim's ex-boyfriend, Desean J. Goings, 27 of Sauk Village gained entry into the victim's apartment by breaking a bedroom window. Goings was arrested, and charged with Residential Burglary and Criminal Damage to Property. Goings was processed and transported to the Will County Adult Detention Facility.
- 5/19 Disorderly Conduct – 35th & Green St. At approximately 12:18 am, a subject was talking on the phone, engaged in an argument with his ex-girlfriend. The subject was confronted by a resident who engaged in a verbal dispute with the subject and brandished a BB gun rifle. A Local Ordinance citation was issued to the resident for Disorderly Conduct.
- 5/19 Theft – 3300 Block of Butler. Offender unknown removed a freezer and table from the victim's son's backyard. TOT Investigations.

- 5/19 Neighborhood Dispute – 3100 Block of Butler Ave. Verbal dispute between neighbors regarding discipline of their children. Parties worked out differences, peace restored.

- 5/21 Motor Vehicle Theft – 22331 Cottage Grove Ave. A 1998 Ford F-150 was removed from the rear East parking lot. Staff advised the vehicle was dropped off years ago, and they had it removed from the property.

- 5/21 Deceptive Practice – 35 W. 34th St. Victim reported a family member fraudulently used credit cards and accessed a checking account without permission. TOT Investigations.

- 5/22 Domestic Battery – 0-100 Block of E. 34th St. Verbal altercation escalated, and became physical. Mutual combatants, unable to substantiate complaints. Parties separated, DCFS contacted for minor child in residence. Parties separated, peace restored.
- 5/22 Theft – 400 Block of W. 34th St. Victims reported they were in the process of moving out, left the apartment for a few hours, and returned finding personal items missing from their apartment. The victims spoke to the apartment complex management, who believed the victims had moved out. TOT apartment management, civil issue.
- 5/23 Retail Theft – 20 E. 34th St. (Party Liquors). Two offenders stole two bottles of liquor. Police are investigating, charges pending.
- 5/23 Suspicious Circumstances – 300 Block of Dorsetshire Dr. Witness reported suspicious activity a neighbor's house. A male black, wearing an orange shirt and sunhat, along with a female white, blond hair wearing glasses, blue jeans, and a pink shirt attempted to gain entry into the residence with a crowbar. The subjects left in a black SUV. Police checked the residence and found it secured. Police are investigating.
- 5/23 Unwanted Subject – 3329 Chicago Rd. (Glass Tap). Police were dispatched to the business for an altercation between two female patrons. Parties separated prior to police arrival. Staff requested the subjects be removed from the property for the night. Subject departed without incident.

- 5/24 Recovered Stolen Vehicle –670 E. Sauk Trail. Police responded to the area with the Steger Fire Department for a vehicle engulfed in flames. The vehicle, a 2019 Lexis EX350 was reported stolen out of Chicago. TOT Chicago P.D.
- 5/24 Disturbance – 3200 Block of Florence Ave. Conflict involving neighbors treatment of dogs left in the residence. Police stood by until a tenant packed up and left the residence. The dogs were left in the neighbors care.
