- 7/6 Domestic Dispute – 3000 Block of Phillips Ave. Verbal altercation between cohabitants. Information provided for an Order of Protection. Report on file.
- 7/7 Juvenile Complaint – 3600 Block of Peoria St. Ongoing problem between two juveniles. Police spoke to both parties and their parents. Advised not to have contact with each other, Peace restored.
- 7/8 Domestic Battery – 3100 Block of Wallace Ave. Victim told police she was involved in a verbal dispute with her husband. The altercation escalated and became physical. The victim declined prosecution. Information provided to obtain an Order of Protection.
- 7/9 Domestic Dispute – 22800 Block of Wentworth St. Parents accused their daughter of taking money. The daughter denied the accusations. Parties separated, peace restored.
- 7/9 Harassment through Electronic Communication – 3400 Block of Sally Dr. Victim reported receiving harassing text messages from a friend. The victim was advised not to have further contact, and was provided information to receive a No Contact Order.
- 7/10 Harassment through Electronic Communication. Victim has been receiving text messages from her estranged husband. Information was provided to obtain an Order of Protection.
- 7/10 Arrest Warrant – Steger Police Detectives picked up Ronald C. Giglio, of Cedar Lake, IN. from the Lake County Indiana Jail for an active arrest warrant. Giglio was charged with a Class 1 Felony for Criminal Sexual Assault with a victim who is at least 13 years of age but under 18 years of age and holds a position of trust, authority or supervision in relation to the victim. Giglio was transported to the Cook County Adult Detention Facility, and awaits a Pre-Trial Detention Hearing.

- 7/11 Burglary to Motor Vehicle, CDP – 3500 Block of Sangamon St. Offender(s) unknown broke the rear window of the victim's 2014 Hyundai to gain entry. Missing property is still to be determined. Police are investigating.
- 7/11 Domestic Disturbance – 3700 Block of Green St. Altercation between family members. Conflicting statements. Unable to substantiate criminal complaints. Parties separated, peace restored.
- 7/11 Disorderly Conduct, Trespass – 3507 Shell Gas Station). Subject was asked to leave by staff. The subject yelled profanity and threatened bodily harm to the staff member. The subject was gone upon police arrival. Police located the subject and advised him not to return to the business and provided him a ride to public transportation.
- 7/11 Criminal Trespass – 3327 Chicago Rd. (Glass Tap). Roger M. Hutchinson, 39 of South Chicago Heights was asked to leave the business by staff. Verbal altercation ensued, and the subject departed. Hutchinson was located by police and issued a Trespass Notice.

Gamero, 28 of Chicago Heights was arrested for DUI Under the Influence Alcohol, Other Drugs, Intoxicating Compounds, Suspended Registration, and Operation of Uninsured Motor Vehicle. - 7/11 Harassment, CDP – 300 Block of W. 34th St. The victim reported being harassed by an ex-girlfriend. When she pulled up to his residence he began filming her on his phone and she drove away. Over the last week someone scratched his 2017 Bentley. The victim has an active Order of Protection against the suspect. TOT Investigations.
- 7/11 Motor Vehicle Theft – 436 W. 34th St. (Burrito Express). The victim told police he parked his 2021 Mazda CX9 in the parking lot with the engine running. He took his key fob with him and entered the business. He was only in the business for five minutes, and when he returned his vehicle was gone. Police are investigating.
- 7/11 Criminal Damage to property – 0-100 Block of W. 31st St. Offender unknown broke the sliding door window on the victim's Dodge Caravan. Police are investigating.
