- 7/27 Motor Vehicle Theft – 400 Block of W. 34th St. Victim reported his 2015 Kia Optima stolen from the parking lot. The vehicle was recovered in Richton Park.
- 7/28 Theft – 3400 Block of S. Kings Rd. The victim told police she was hosting a birthday party at her apartment and someone removed her Glock, Model 43, 9mm handgun. The gun was kept unsecured, on top of the kitchen table. Police are investigating.
- 7/30 Telephone Threat – 3030 Chicago Rd. (Steger Medical Clinic). Staff received threatening telephone calls from a subject who didn't meet the requirements for admittance. Extra patrol requested, report on file.
- 7/30 Battery – 3325 Chicago Rd. (Little Caesars). While the victim was delivering supplies for the business, he was approached by Kimberley N. Johnson, 33 of Country Club Hills. Johnson demanded \$3.00 from the delivery driver. When he refused, Johnson struck him in the head. Johnson was cited and released.
- 7/30 Telephone Harassment – 3500 Block of S. Kings Rd. Victim received numerous harassing phone calls over the past few years. It is believed the telephone calls are related and by the same offender. Report on file.
- 7/30 Neighborhood Dispute – 0-100 Block of W. 31st St. Resident was upset due to the neighbor watering their lawn, getting water on his vehicles. The neighbor explained the water pressure fluctuates and it was not deliberate. Report on file.
- 7/30 Domestic Disturbance – 3000 Block of Halsted St. Victim reported she needed to get access to her vehicle but it was blocked by her brother's vehicle. Police mediated a resolution and the vehicle was moved. Peace restored.

belongings. It was purported she threatened her mother with shooting up the house. Police mitigated a peaceful resolution. The daughter retrieved her property. The mother was given information to obtain an Order of Protection. Peace restored.

- 7/30 Warrant Arrest – 100 Block of Sandy Ridge Dr. Leodis Norswether, 40 of Steger called the police to be escorted to his mother's residence to retrieve personal property. Norswether was taken into custody for an outstanding warrant for a previous Domestic Battery charge. Norswether was also served with a copy of an active Order of Protection. Norswether was processed and transported to the Will County Adult Detention Facility.
- 7/30 Suspicious Person – 3200 Block of Emerald Ave. At approximately 11:36 pm a resident observed a male subject wearing black and blue attire, wearing what appeared to be a shirt covering his face looking through her bedroom window. The subject was gone upon police arrival. Extra patrol conducted, TOT Investigations.
- 7/31 Domestic Trouble – 3100 Block of Wallace Ave. Complainant advised she was involved in a verbal dispute with her husband. When she exited her residence, he locked her out. Police mitigated a peaceful resolution, both parties returned inside, peace restored. The subject fled southbound from the victim's residence.
