- Attempt Motor Vehicle Theft, Criminal Damage to Property 0-100 Block of E. 34<sup>th</sup> St. The victim told police her parked his 2018 Kia Forte in the back of his residence near the alley at approximately 10:00pm on 8/9/24. When he returned at approximately 4:30am on 8/10/24 he discovered the driver side window broken. Upon further investigation he learned the offender(s) damaged the steering column.
- 8/10 Traffic Arrest 1030 Main St. Crete, IL. Police were investigating a Hit & Run accident that occurred in the 3700 Block of Chicago Rd. Offices located the vehicle with the help of FLOCK cameras. Shy Ann Monique McDowell, 22 of Beloit WI. Was cited for Leaving the Scene of a Property Damage Accident, Improper Overtaking on the Right, and Operation of Uninsured Motor Vehicle. McDowell was cited and released. The offender's vehicle was towed from the scene.
- Aggravated Fleeing & Eluding 34<sup>th</sup> & Wentworth Ave. Police were alerted by Flock cameras of a Felonious vehicle in the area. The vehicle was observed at 34<sup>th</sup> & Wentworth. Police attempted to stop the vehicle, but met with negative results.

Several days later the subject returned and took her car. When he returned a verbal altercation ensued. The police were called to the scene but the offender fled prior to police arrival. Police are investigating.
