- 8/17 Domestic Dispute – 100 Block of Lake Hill Dr. Altercation between the victim and her ex-boyfriend. The victim wanted the subject to leave her residence. The subject gathered the property and departed.
- 8/17 Theft – 3507 Chicago Rd. (Circle K). Store staff advised a subject took \$248.00 worth of merchandise without making payment. The offender is described as a male white in his late 40's wearing a black tank top and jean shorts. The offender fled in a white Kea Optima. Police are investigating.
- 8/18 Domestic Dispute – 3000 Block of Green St. Verbal altercation between cohabitants. One of the parties ingested an undetermined amount of pills. The subject was transported to St. James Hospital in Olympia Fields.
