- 8/26 Domestic Trouble – 3200 Block of Phillips Ave. The complainant reported having marital problems with her husband. Information provided for an Order of Protection. Report on file.
- 8/27 Traffic Arrest – Richton Rd. & Crystal Ln. Andreina Jhhonna Mendoza, 28 of Chicago was arrested for No Valid Driver’s License, Disobeying a stop sign, and Operation of Uninsured Motor Vehicle. Mendoza was cited and released.
