- Aggravated use of a Weapon 3200 Block of Butler Ave. Police were dispatched to the area for a report of two occupants slumped over in a vehicle. Police made contacted with the two subjects, who appeared to be intoxicated. One of the occupants went inside the house and the other person requested a ride to an address in Steger. Prior to placing the subject in the back of a patrol car, the officer conducted a pat down, asking if the subject had any weapons. The subject indicated he had a pistol in his pocket. Officer retrieved the weapon and arrested the motorist, Stephen MJ Byrnes, 23 of Crown Point Indiana for Aggravated Unlawful Use of Weapon. Byrnes was provided a notice to appear, and released. The weapon was entered into evidence. The offender's vehicle was towed and impounded.
