- 9/7 Assist Other Police Agency 36th & Union Ave. Police were notified of a Flock Safety Camera Notification regarding a stolen Hyundai Elantra traveling Westbound Steger Rd at State St. Police verified the status of the vehicle through dispatch, who confirmed and provided additional information that the felonious vehicle was wanted by the Worth Police Department for attempted Homicide.
 - The vehicle was located and stopped at 36th & Union Ave. the motorist was released at scene, TOT Worth Police Department.
- Possession of Stolen Motor Vehicle Beckwith Ln. Steger Police were advised by Crete Police of a Stolen Audi Q5, bearing Connecticut Dealer Plates traveling Westbound Steger Rd. from IL-394. The vehicle was located and stopped at IL-394 & Beckwith Ln. The driver, Kene E. Menifield, 27 of Antioch, TN. Was taken into custody. Menifield, was transported to the Police Department, Charged with Possession of Stolen Vehicle, and Unlawful Possession of Title or Registration Documents. The license plates on the stolen Audi were confirmed by the Connecticut State Police dispatch to be factious. Menifield was provided a Notice

to Appear, and released. The stolen vehicle was towed from scene.
