- 9/14 Domestic Battery 100 Block of E. 31st St. Juvenile victim reported being involved in a verbal altercation with his mother and mother's boyfriend. The altercation escalated and the juvenile was held down by the boyfriend. DCFS notified, TOT Investigations.
- 9/14 Violation of Order of Protection 0-100 Block of W. 35th St. Victim reported receiving harassing voice messages from her ex-boyfriend. The contact violates an active Order of Protection against her ex-boyfriend. TOT Investigations.
- 9/15 Burglary to Motor Vehicle 2200 Block of Lahon Rd. Offender unknown entered the victim's unsecured 2002 Ford pickup truck. It is unknown what items were taken at this time. TOT Investigations.
- 9/15 Traffic Arrest 100 Block of W. Richton Rd. Police conducted a traffic stop on a motorist, Trezhay C. Wash,30 of University Park for speeding 45mph in a posted 30 mph zone. Walsh was also cited for No Valid Driver's License, and Operation of Uninsured motor Vehicle. Walsh was issued a Notice to Appear, and released. The vehicle was removed from scene by a valid driver.
- 9/15 Burglary to Motor Vehicle 0-100 Block of E. 227th St. Offender unknown entered several unsecured vehicles owned by the victim and other family members, and removed approximately \$100.00 U.S.C. Video surveillance depicts a subject, wearing a light colored hoodie, mask, and dark jeans entering the vehicles. Police are investigating.

- 9/19 Fraud 300 Block of W. 34th St. Victim received a message that he thought was his bank (BMO Bank) advising of declined activity from Best Buy in Columbus Ohio. He was instructed to send money in Vanilla Gift Cards, and ECASH. The victim complied. TOT Investigations.
- 9/19 Theft 3400 Block of S. Kings Rd. Offender unknown stole a Package that was delivered to the victim. Police are investigating.

- 9/19 Retail Theft 20 E. 34th St. (Party Liquors). Staff told police a subject came into the store and removed three (3) 1.75 L bottles of Tito's vodka, valued at \$104.97 without making payment. Police were shown video surveillance of the incident. The subject was seen getting into a red SUV, that drove eastbound on Steger Rd. Police were able to locate the vehicle utilizing Flock Safety Cameras. During the traffic stop the offender fled on foot. Police gave chase, captured the subject, and took him into custody. The offender, Naylan Abegg, 20 of Cedar Lake, IN. was charged with Retail Theft, Criminal Trespass, and Resisting Obstructing Peace Officer. The offender was released on a Will County Notice to Appear.
- 9/20 Retail Theft, Sex Offender Registration (Failure to Register) 3401 Chicago Rd. (7-Eleven). Police were called for a report of a Retail Theft. The offender, Mark P. Montsvil, 54 was located and issued a Local Ordinance citation for Retail Theft. A criminal check was conducted on Montsvil, that reveled he was a non-compliant sex offender. Montsvil was charged with failing to register as a Sex Offender. Montsvil was processed and transported to the Will County Adult Detention Facility.
