- 10/5 Domestic Battery – 35th & Carpenter St. Victim reported being slapped by her boyfriend. Police checked the area, but were unable to locate the offender. Information was provided to obtain an Order of Protection. TOT Investigations.
- 10/5 Telephone Harassment – 3600 Block of Halsted Blvd. Victim reported receiving harassing phone call from an ex-friend. Information provided to obtain a No Contact Order.
- 10/5 Aggravated Assault – 3327 Chicago Rd. (Glass Tap). Staff member told police she requested a patron, who was banned from entry to leave. The subject refused and displayed Brass Knuckles. A group of patrons stopped the offender from approaching the staff member. Police had the opportunity to speak to the offender, who came to the police station. Conflicting statements, unable to substantiate complaints, TOT Investigation.
- 10/6 Mini Bike/ATV Complaints – 3400 Block of Hopkins Ave. Police stopped motorist, Craig Fanello, 35 of Steger for operating an ATV on the roadway. Fanello was cited for Improper Operation of ATV on Roadway, Defective Brake Lights, and Operation of Uninsured Motor Vehicle. Fanello was provided a Notice to appear, and given a ride home. The offender's vehicle was towed and impounded.
- 10/7 Disturbance – 3327 Chicago Rd. (Glass Tap). Verbal altercation between business owner and acquaintance. The business owner displayed a firearm, but did not point it at the individual. The subject departed without further incident. Police located the subject walking in the area and issued him a No Trespass Notice.

- 10/7 Domestic Dispute 400 Block of W. 34th St. Reporting Party told police she was involved in a verbal altercation with her husband. The argument escalated and her husband tried to burn her with a bottle of butane and a lighter, but was unsuccessful. Police checked the apartment, her husband was not on scene. Information was provided to obtain an Order of Protection.
- 10/7 Domestic Disturbance – 400 Block of W. 34th St. Altercation between boyfriend and girlfriend. Parties separated, peace restored.
- 10/8 Harassment through Electronic Communications – 35 W. 34th St. Victim reported receiving harassing text messages from his ex-girlfriend. Information was provided to obtain and Order of Protection.
- 10/9 Aggravated Fleeing & Eluding – 34th & Chicago Rd. Police observed a Black Kia Stinger, that was reported stolen by the Illinois Secretary of Police. Police attempted to stop the vehicle, but met with negative results.
- 10/10 Criminal Damage to Property – 3400 Block of Union Ave. Offender unknown threw a brick through the victim's bedroom window. Police are investigating.
- 10/11 Domestic Dispute – 3300 Block of Wallace Ave. Altercation between cohabitants. Information provided to obtain an Order of Protection. Parties agreed to stay in separate areas of the house, peace restored.
