- 10/19 Criminal Trespass 3507 Block of Chicago Rd. (Circle K Gas Station). Staff reported a subject came into the business and removed merchandise without making payment. Police located the subject, who stated he brought his own food inside the business and used the microwave. An employee checked the surveillance footage and was unable to determine what items were taken. Marco Alberto Espinosa, 25 of Crete was served with a Trespass Notice and released.
- 10/20 Domestic Dispute 3300 Block of Emerald Ave. Altercation between family members. One of the parties requested to go to the Hospital. EMS was contacted and transported the subject to St. James Hospital in Olympia Fields.
- 10/20 Fleeing & Eluding 300 Block of W. 35th St. Police observed a blue Honda Accord with no registration driving in the area of the Linden Park Apartments. Police had previous contact with the vehicle that was reported stolen out of Matteson. Police attempted to stop the vehicle but met with negative results.
- 10/20 Disturbance 3215 Union Ave. (Signature Bar & Grill). Police were dispatched to the business for a disturbance. Police were met by a group of family members, who refused to cooperate with police. Unable to substantiate criminal complaints. All parties were told to leave, peace restored.
