- 5/3 Domestic Dispute – 3000 Block of Peoria St. Verbal altercation between family members. Police mitigated a peaceful solution. TOT Crisis Center of South Suburbia.
- 5/3 Domestic Disturbance – 3100 Block of Green St. Police responded to this location numerous times. Verbal altercation between family members. Parties separated, peace restored. TOT Crisis Center of South Suburbia.
- 5/4 Criminal Damage to Property – 300 Block of W. 35th St. Offender unknown damaged the victim's 2020 Buick Encore, while parked in the apartment complex parking lot. Prosecution declined, case closed.
- 5/4 Domestic Trouble – 3500 Block of Phillips Ave. Victim reported her husband followed her to a relative's house, and was intimidating her. The victim does have an Order of Protection, but has not been served at the time of this report.
- 5/5 Domestic Dispute – 3400 Block of Green St. Verbal altercation between husband and wife. Parties agreed to separate from each other. Information provided to obtain an Order of Protection.
- 5/5 Domestic Trouble – 3100 Block of Carpenter St. The reporting party told police her ex-boyfriend was kicking the door. Police located the subject and advised him not to return to the residence. Information provided to obtain an Order of Protection. The case was forwarded to the Crisis Center of South Suburbia.

- 5/5 Traffic Arrest – 300 Block of E. 34th St. Motorist, Dana A. Parks, 23 of Country Club Hills was stopped for a traffic infraction. A driver's license inquiry revealed Parks' driver's license was revoked. The motorist was cited for Failure to Dim Headlights, No Valid Registration, Operation of Uninsured Motor Vehicle, and Driving While License Revoked. Parks was issued a Notice to appear, and released. The offender's vehicle was towed and impounded.
- 5/6 Harassment – 3000 Block of Sangamon St. Resident reported being harassed by previous tenants. Resident advised to contact police if the tenant returns. Information provided to obtain a No Contact Order.
- 5/6 Domestic Disturbance – 3100 Block of Green St. Police responded to this location numerous times. Verbal altercation between family members. Police served the respondent with a copy of the Order of Protection. TOT Crisis Center of South Suburbia.

- 5/9 Domestic Battery – 94 W. Richton Rd. Connie Hughley, 39 of Steger was arrested for Domestic Battery. Hughley was processed and transported to the Will County Adult Detention Facility.
