- 5/10 Retail Theft 500 W. Steger Rd. (Shell Gas Station). Unidentified male black, described as tall, wearing a black tracksuit with a hoodie, and white T-shirt covering his face stole alcoholic beverages. The offender told the clerk he had a knife and threatened to hurt him if he tried to stop him. The offender exited the business and headed into the Linden Park apartments. Police are investigating.
