5/17	Unwanted Subject – 3327 Chicago Rd. (Glass Tap). Patron was verbally abusive towards a staff member. Subject told to leave the establishment, peace restored.
5/17	Domestic Disturbance – 3400 Block of S. Kings Rd. Verbal altercation between boyfriend and girlfriend. Parties advised to separate for the remainder of the evening. Peace restored.
5/17	Traffic Arrest – 34 th & Hopkins Ave. Robert Tucker, 23 of Blue Island was stopped for Aggravated Speeding, 91 mph in a posted 30 mph zone. Tucker was cited for Aggravated Speeding and Reckless Driving. Tucker was provided a Will County Pre-Trial Notice to Appear, and released.
